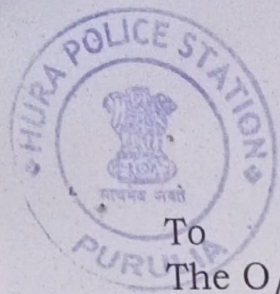

Sir,

In producing herewith seized vehicle bearing Reg. No. NL01AC/5612 (Truck) with loaded, I beg to submit that on 29.08.2022 I ASI Chiranjit Pal along with C/711 Durgapada Barik, JC/1499 Partha Mandal, HG/1535 Pravas Ruhidas all of Hura PS were performing night mobile duty vide Hura PS C.C No-2028/22 dtd. 29.08.2022 and Hura PS GDE No-1316, dtd- 29.08.2022 and while we reached at near Kulgora morh under Hura PS (Purulia-Bankura NH60A road) on 30.08.2022 at about 06:00 hrs. we found one vehicle having Registration No. NL01AC/5612 (Truck) with loaded was going towards Purulia side with rash and negligently and overturned beside the road (Purulia-Bankura NH60A road) at BORO PULL near Kulgora morh under Hura PS. We rushed to the spot and found that the said vehicle has been not damaged. On seeing police party the driver fled away. The accident occurred due to rash and negligent driving of the driver of the said vehicle.

Accordingly, I seized the above noted vehicle by preparing seizure list (details are mentioned in the attached seizure list) with a view to prosecute him U/S 279 IPC.

Hence I pray that a specific case U/S 279 IPC may kindly be initiated against the driver of vehicle bearing Reg. No. NL01AC/5612 (Truck) with loaded and arrange for its investigation.
