

Most respectfully Seweth;

- 1. That, both the parties are the residents of this District which is under your Jurisdiction.
- 2. That, your petitioner, i.e., the complainant was married with accused No. (1) on 01/06/2020 in presence of both the parties relatives at the house of the father of the complainant, As per the Hindu Marriage Act, Shastras, Customs, of their Society.
- 3. That, as per the demand of the accused party, the father of the complainant gave a cash of Rs. 25,000/-, one Bhari Gold Oranaments, Almirah, Palank, various Utencils of Total Rupees 1,50,000/-.
- 4. That, after marriage your petitioner started living with her husband peacefully at her matrimonial house.
- 5. That, after one year your petitioner realized that the attitude, behavior of the family members, including her husband has been changed.
- That, all the accused persons used to torture your petitioner both mentally and physically on the pretension that she had brought a very small amount of dowry.

- 9. That, the father of the complainant being a poor Rickshaw puller somehow managed an amount of Rs. 10,000/-, and gave her daughter to pay them.
