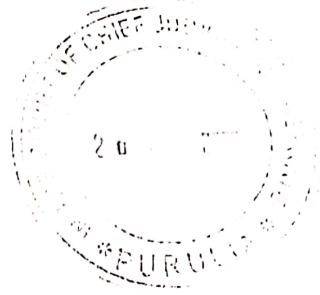

The humble submission on behalf of your petitioner,

Most respectfully Seweth;

1. That, both the parties are the residents of this District which is under your Jurisdiction.
2. That, your petitioner, i.e., the complainant was married with accused No. (1) on 01/06/2020 in presence of both the parties relatives at the house of the father of the complainant, As per the Hindu Marriage Act, Shastras, Customs, of their Society.
3. That, as per the demand of the accused party, the father of the complainant gave a cash of Rs. 25,000/-, one Bhari Gold Ornaments, Almirah, Palank, various Utencils of Total Rupees 1,50,000/-.
4. That, after marriage your petitioner started living with her husband peacefully at her matrimonial house.
5. That, after one year your petitioner realized that the attitude, behavior of the family members, including her husband has been changed.
6. That, all the accused persons used to torture your petitioner both mentally and physically on the pretension that she had brought a very small amount of dowry.
7. That, all the accused persons used to direct your petitioner to go her father's house at Jhalda to bring more cash of Rs. 50,000/-, for starting of business of the accused No. (1)
8. That, the complainant, being unable to deny the accused persons, reached her father and stated everything.
9. That, the father of the complainant being a poor Rickshaw puller somehow managed an amount of Rs. 10,000/-, and gave her daughter to pay them.

10. That, the accused persons were not satisfied with the amount and the tortures upon her continued. They used to keep her without proper food, proper dress and she had to do all domestic works including fetching water, etc., for all of them.
11. That, your petitioner considering that someday everything will be good in near future.
12. That, on 24/01/2022 at about 7 p.m. all the accused persons with a common intension started beating your petitioner mercilessly with iron rod, bamboo sticks, fist and blow and driven her out from the house by pushing her roughly and she felled on the earth.
13. That, your petitioner somehow reached her fathers house and since then she has been living with him.
14. That, your petitioner learnt from a source that the accused No. (1) with the support of other accused persons married one girl namely Kunti Kalindi D/o. Nimai Kalindi, Vill- Talgaria, P.S.- Chandankiary, Dist- Bokaro(Jharkhand) second time.
15. That, your petitioner informed the Jhalda Police Station in details of the fact but to no result.
16. That, your petitioner also filed complain before the S.P. Purulia, but to no effect.
17. That, finding no other way, your petitioner is compelled to file this petition before your Ld. Court.

It is therefore prayed that your honour would graciously be pleased to send this petition to the I.C., Jhalda Police Station directing him to treat this as F.I.R. as contemplated U/s. 156(3) Cr.P.C.
