
Subject - Lodging of FIR against Sri Soumyak Bhattacharya,

Sir,
I, Sri Arnab Sen Majumder, s/o Sri Bankar Sen Majumder, aged 34 years working in the capacity of Inspector Posts, (Purulia West Sub-division) would like to inform you that consequent upon receipt of information regarding unauthorised absence of Sri Soumyak Bhattacharya, GDSBPM Patihalda BO, proceeded immediately to Patihalda BO & found Sri Bhattacharya to be absconding since 13/08/2022. Along with him few valuable documents like BO account book, BO journal, Scheme wise journal, Preliminary Receipt Book etc are missing resulting in major disruption in public service. Also, the electronic (RICT) device allotted to him along with the peripherals are untraceable. This will cause serious hampering of public service. Prima-facie it appears said Sri Bhattacharya has misappropriated with all these official documents as well as the device with criminal intent.

Please treat this letter as an FIR and oblige by lodging the same.
