Sir,

In producing here with one arrested accused person namely Shibu Kandu (26) S/O Subar Kandu of Vill- Deondera, PS-Jhalda, Dist-Purulia and brought under seizure one Yellow Black colour Honda Activa Motor Cycle (Scooty) bearing Reg. No- JH 01EC 4769 before you.

I SI Asoke Kr. Sen of Jhalda PS do here by lodged a written complaint against Shibu Kandu (26) S/O Subar Kandu of Vill- Deondera, PS-Jhalda, Dist-Purulia to the effect that today (29/08/2022) while performing Day mobile duty (This refers to Jhalda P.S. GDE No- 1245 Dt-29/08/2022, in consonance with C.C. No- 2317 Dt- 29/08/2022) along with force namely 1) RM/1504 Sachin Chhetri 2) RM/1526 Sunil Kr. Rai both of EFR 3rd Battlion, Salua, Dist-Paschim Medinipur, Camp at Jhalda PS in PS area. As per your order, I started MV checking at Old PS Gate along Purulia Ranchi Road (SH-4A) after placing guard rail. During MV checking at about 16.15 Hrs I detained one Motor Cycle coming from Jhalda Town side driving so rash and negligently which was identified as dangerous driving with two pillion riders. The rider and the two pillion riders were without wearing protective headgear that could be identified as the dangerous driving of any motor vehicle. Subsequently I intercepted the said motor cycle having Reg. No- JH 01EC 4769. On interrogation the rider having the control of the motor vehicle disclosed his identity as mentioned above and on asking the pillion rider of said motor cycle disclosed their identity as Suraj Kandu (19) S/O Ajit Kandu of Vill- Deondera, PS-Jhalda, Dist-Purulia and Dipak Kandu (18) S/O Jagadish Kandu of Do. As the rider of the motor vehicle having control could not give satisfactory reason of his rash and negligent driving which could be taken into consideration as dangerous driving. Subsequently, I seized the said motor cycle and arrested the rider having control of the motor vehicle for violating the Sec-279 IPC & R/W Section-184/194D/194C MV Act after maintaining all the formalities as well as guidelines of Hon'ble Supreme Court and NHRC regarding arrest.

I, therefore pray before you to start a specific case against accused rider having control of the motor vehicle namely Shibu Kandu (26) S/O Subar Kandu of Vill- Deondera, PS-Jhalda, Dist-Purulia U/S 279 IPC & R/W Section-184/194D/194C MV Act and arrange for its investigation.
