## Most respectfully begs to state:-

- 1. That the complainant has purchased a 2<sup>nd</sup> hand vehicle bearing Registration No. JH-20B/3360 from Santosh Kumar Roy, S/o- Rammoy Roy, of Katin Para, Purulia Municipal Ward No. 10, P.O- Purulia, P.S- Purulia (T), Dist- Purulia, under hire purchase with Cholamandalam Investment & Finance Co. Ltd. Having its branch office at Raghabpur More, P.O, P.S & Dist- Purulia, and since finance / purchase of the vehicle he used to pay monthly installment regularly and used to ply the vehicle. Subsequently, after purchase the name of the vehicle was transferred in his name.
- 2. That all of a sudden on 12/03/2022 when the family members of the complainant while going to Dhanbad, and when they reached near Joypur Kali Mandir, at that time some of the officials of Shriram Transport Finance Co. Ltd., i.e Branch Manager namely Iman Afroz, i.e the accused No. 1, Amresh, collection manager / recovery agent i.e accused No. 2, Nagendra Yadav, collection manager / recovery agent, i.e accused No. 3 and some 3 / 4 others of Shriram Transport Finance Co. Ltd, having it's office at Sector IV, R.S Plot No. S-3, 1st Floor, Bokaro, PIN- 827004, by using criminal force confined the vehicle of the complainant and forcible and dishonestly took possession of the vehicle including all its connected documents and obtained the signature of the driver of the complainant namely Jayanta Kalindi, in a vehicle inventory list and on some other blank format by putting the driver in fear of injuries without his consent and also without the consent of the family members.
- 3. That after the incident the complainant had been to the office of Shriram Transport Finance Co. Ltd., Bokaro Branch and asked to assign the reason for illegal and forceful taking possession of the vehicle, then the above-named persons replied that the vehicle is under hypothecation of Shriram Transport Finance Co. Ltd., and the name of the borrower is one Chandi Dhibar.



- 4. That the complainant made several request to the above named accused persons to release of the vehicle as he has purchased the same from Santosh Kumar Roy and previously there was no hypothecation in the name of anybody as it disclosed from the R.C Book of Santosh Kumar Roy, but they did not pay any heed to the complainant, and threatened the complainant in dire consequences that if the complainant have not make payment of the dues amount, they will not release the vehicle, rather they will sold the vehicle in auction and also initiate appropriate proceeding against the complainant.
- 5. That under the circumstances set forth above it is crystal clear that the above named accused persons along with some others by hatching a criminal conspiracy dishonestly took the vehicle without the consent and also put in fear of injury to the driver and thereby dishonestly induces him so put in fear to deliver the vehicle, prepare some false accounts and demanded money and thereby committed the offence of theft, extortion, forgery, cheating and various other offences.
- That after the incident the complainant had been to the Joypur P.S in order to lodge a complaint, but the duty officer refused to accept the same, accordingly the complainant posted the complaint through registered post on 23.05.2022, and the same was delivered on 24.05.2022, but no action has been taken.
- 2. That subsequently, the Complainant on 25.05.2022 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156 (3) Cr.P.C. before Your Honour's Court.

It is therefore prayed that your Honour will be graciously pleased to send this petition to Inspector-in-charge of Joypur P.S. to treat this petition as an FIR as contemplated u/s 156(3) Cr. P.C. and to investigate the case in accordance with law and to unearth the wrongdoer
