Sub: Prayer for starting a specific case against one Maniram Sahis (24 Yrs) S/O- Nepal Sahis of Vill-Padudih PO-Sardaha PS-Pindrajora, Dist-Bokaro (Motor Cycle Rider having Regd. No-JH09AV-6444 Black Colour Hero Splender+).

Respected Sir,

With due respect I SI Manas Kumar Panda, beg to submit before you that on 17/08/2022 at about 11:05 hrs while myself along with JC/-1575 Uttam Mandal, NVF/-1011 Ishan Mandal were performing Special Mobile-1 duty vide Joypur PS CC No-82/22 Dated-17/08/2022 in front of RIK Auto Mobile at Joypur Town on Purulia-Ranchi Road (SH-4A). I found one Motor Cycle was coming from Purulia side towards Jhalda with **Driving Dangerously & Without Helmet**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him in-front of RIK Auto Mobile at Joypur Town on Purulia-Ranchi Road (SH-4A). On interrogation he made incoherent statement at different time. He disclosed his identity as Maniram Sahis S/O- Nepal Sahis of Vill-Padudih PO-Sardaha PS-Pindrajora, Dist-Bokaro. On being asked he failed to produce any other valid documents of Motor Cycle. Hence he violated the provision of Section 279 IPC & R/W Section-184/194 MV Act. So I seized the One Black coloured Hero Splender Plus having Regd. No-JH09AV-6444 at 11:35 hrs to 11:45 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Maniram Sahis (24 Yrs) S/O- Nepal Sahis of Vill-Padudih PO-Sardaha PS-Pindrajora, Dist-Bokaro at 11:55 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailable hence accused rider namely Maniram Sahis was released on bail.

So I pray specific case may kindly be registered against the accused namely Maniram Sahis (24 Yrs) S/O- Nepal Sahis of Vill-Padudih PO-Sardaha PS-Pindrajora, Dist-Bokaro (Motor Cycle Rider having Regd. No-JH09AV-6444 Black Colour Hero Splender+) for committing offence U/S-279 IPC & R/W Section-184/194D MV. Act.
