This is to inform you that 11 KV Joypur Town feeder emanated from Joypur 33/11 KV substation to feed electricity to Joypur Town. On 20.08.2022 Joypur Town feeder breakdown occurred at about 20:10 hrs and after that HT maintenance team went for patrolling on above mentioned feeder. During line patrolling near Vaddih Village one no PCC Pole of above mentioned feeder was found to be intentionally uprooted and damage from its base by some unknown miscreants for their vested interest best known to them. Therefore due to such intentional unauthorized mishandling of electrical network may lead power interruption in vast area of Joypur Town and also may be the cause of electrical accident.

In this situation you are requested to take cognizance of the matter and do needful as per law to safeguard the greater interest of the common people under your jurisdiction.
