

Sub: Prayer for lodging FIR against accd Ajan Majhi (45), s/o- Lt Karma Majhi of Vill- Dhadkidih, Po-Sidhi, PS-Joypur, Dist-Purulia, U/S 46A (c) B.E. Act 1909.

Sir.

In producing herewith arrested accused Ajan Majhi (45), s/o- Lt Karma Majhi of Vill- Dhadkidih, Po-Sidhi, PS-Joypur, Dist-Purulia, along with seizure - list and seized items as described below, I beg to state that on 30.08.22 at about 17.45 hrs dunging my evening mobile duty (vide CC No-1567/22), received a source information to the effect that the illicit liquor (Mohulla) has been kept at Dhadkidih morh in to the house of above noted accused illegally with an object to sale. I convey the matter to the IC Joypur PS and as per order of IC Joypur PS. I along with force left for Dhadkidih village to work out the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the house of Ajan Majhi at about 18.15 hours. Seeing police van some unknown persons in front of the house of Ajan Majhi fled away. However, I could detain Ajan Majhi and asked about his identity, he disclosed his name and identify as above and as well as informed also that he gather the illicit liquor (locally known as Mohulla) for selling and he was the owner of the said house. However, I along with said accused started a search inside the house of Ajan Majhi and found the following item in the said house:

1) One white colour plastic Jariken containing approx 10(ten) Lit. illicit liquor (locally known as Mohulla)

I interrogated him about the purpose of the stocking and possessing illicit liquor. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List in between 18:25 hrs and 18.40 hrs & took up its 500ml (approx) into a plastic bottle as sample, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the illicit liquor without any valid papers in his shop has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 18.45 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the said accused Ajan Majhi (45), s/o- Lt Karma Majhi of Vill- Dhadkidih, Po- Sidhi, PS-Joypur, Dist-Purulia.
