



That After reaching to Jolarpettai, the son of the petitioner called her over mobile from his number 1. 6364379582, 2. 8617057334 over her mobile number 7076395665 and acknowledge her about safe reaching and lastly he called her on 12/12/2021 and inform the petitioner that he is not good at there and willing to come back. Later on SISUPAL BOURI informed the petitioner that her son was missing.
- 4. That the petitioner had tried her best to call the above noted person but no fruitful result came out and finding no other alternative the petitioner had lodged one Missing Diary at Kashipur Police Station vide Kashipur PS M.P. case.- 27/21 dated 19/12/2021.
- That now SISUPAL BOURI and NITYANANDA BOURI has returned to village, and when she tried to get information from them about her son, they flatly refused to inform anything to her.
- That the petitioner feels bad for her only child and son, and have every reason to believe that the above noted persons are engaged in the missing/kidnapping of her son or murdered him.
- 7. That the petitioner has informed the matter to S.P. Purulia, with other respective authority with a prayer for the registration and proper investigation of the missing/kidnapping or murdering of her only child on 10/05/2022, duly received by the authority but till to-day there is no any fruitful result.
- That finding no other alternative, the complainant have to take shelter before the ld. Court for the redressal of her grievance.
