Sub: To lodge FIR against owner and driver of 02(two) seized tractors (1)Power Track 439 DESTRUCTION Tractor having Registration No WB81/0950, Chasis No- T053326464KF, Engine No- E3365496, along with trolley (without number plate) loaded with sand approx 50-60 Cft, (2) Power Track 439 DS (Blue Colour) Tractor without No plate, Chasis No- T053499820EJ, Engine No- E3562428, along with trolley (without number plate) loaded with sand approx 90-100 Cft.

In producing herewith 02(two) arrested accd. persons namely 1. Nandalal Kalindi(28 yrs) s/o- Magaram Kalindi of vill- Rangamati, PS- Kashipur, Dist - Purulia, driver of Tractor having Registration No WB81/0950 and 2) Bholanath Kalindi (24 yrs) s/o- Ramswarup Kalindi of vill- Rangamati, PS- Kashipur, Dist - Purulia, driver of Tractor without No plate, Chasis No- T053499820EJ, Engine No- E3562428 along with seized articles i.e. (i)Power Track 439 DS (Blue Colour) Tractor having Registration No WB81/0950, Chasis No- T053326464KF, Engine No- E3365496, along with trolley (without number plate) loaded with sand approx 50-60 Cft, (ii) Power Track 439 DS (Blue Colour) Tractor without No plate, Chasis No- T053499820EJ, Engine No- E3562428, along with trolley (without number plate) loaded with sand approx 90-100 Cft (iii) 02 piece old Iron made "Belcha" having iron butt and (iv) 02 piece iron made "Dhama" before you.

The nub of the fact in a nutshell is that on 25.08.2022 at 21.45 hrs I SI Pratap Ch. Ojha of Kashipur PS along with (i) C/-793 Prasanta Patra and (ii) C/2987 Gurudas Malla both of Kashipur PS, Dist-Purulia, left the PS for performing anti crime night mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 1065 dtd- 25.08.2022 and C.C No. 2357/22 Dtd. 25.08.22. During my night mobile duty, I received a tip off on 26.08.2022 at 03.35 hrs that some persons were loading some tractors with sand from the river bed of Darkeswar River near Samsan Ghat of Kashipur Rajwarpara under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractor. We rushed to the Tractor and detained the said tractor and somehow we managed to apprehend two persons. On interrogation they disclosed their name noted in the supra, who are the driver of said vehicles. I asked the drivers of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicles could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the drivers to produce the valid paper but they stated different statement in different times. The incoherent statement of the drivers purported to be a suspicious one to us. It was ascertained that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So I, seized (1)Power Track 439 DS (Blue Colour) Tractor having Registration No WB81/0950, Chasis No- T053326464KF, Engine No- E3365496, along with trolley (without number plate) loaded with sand approx 50-60 Cft, (2) Power Track 439 DS (Blue Colour) Tractor without No plate, Chasis No- T053499820EJ, Engine No- E3562428, along with trolley (without number plate) loaded with sand approx 90-100 Cft, (iii) 02 piece old Iron made "Belcha" having iron butt and (iv) 02 piece iron made "Dhama" in between 04.05 hrs to 04.25 hrs under proper seizure list in presence of available witnesses duly signed by them and also arrested 1. Nandalal Kalindi (28 yrs) s/o- Magaram Kalindi of vill- Rangamati, PS- Kashipur, Dist - Purulia, driver of Tractor having Registration No WB81/0950 and 2) Bholanath Kalindi (24 yrs) s/o- Ramswarup Kalindi of vill- Rangamati, PS- Kashipur, Dist - Purulia, driver of Tractor without No plate, Chasis No- T053499820EJ, Engine No- E3562428 in between 04.30 hrs to 04.35 hrs after informing the ground of arrest and issued Memo of Arrest against them. Thereafter, I brought the said tractors to Kashipur P.S. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and arrested drivers of above noted tractors along with the trolley for investigation.
