Sub: To lodge FIR against owners and drivers of 02 (Two) seized Tractors (1) Power Track Euro 439 (Blue Colour) tractor having Chassis No T053486076MJ and Engine No E3547413 along with trolley (without number plate) loaded with sand approx 60-65 Cft (2) Mahindra B 275 DI (Red Colour) having Registration No WB 55B/3240 along with trolley (without number plate) loaded with sand approx 50 – 55 Cft.

Sir.

In producing herewith, 02 (Two) tractors i.e. (1) Power Track Euro 439 (Blue Colour) tractor having Chassis No T053486076MJ and Engine No E3547413 along with trolley (without number plate) loaded with sand approx 60-65 Cft (2) Mahindra B 275 DI (Red Colour) having Registration No WB 55B/3240 along with trolley (without number plate) loaded with sand approx 50 – 55 Cft (3) 02 nos of Belcha and (4) 02 nos of Dhama before you.

The nub of the fact in a nutshell is that today on 10.08.2022 at 16.45 hrs. I ASI Shyamal Ch Mandal of Kashipur PS along with (i) C/726 Dipankar Mahato and (ii) C/689 Prabhas Ch Mahato both of Kashipur PS, Dist - Purulia, left the PS for performing anti crime mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 422 Dtd - 10.08.2022 and C.C No. 2230/22 Dtd. 10.08.2022. During my mobile duty, I received a tip off at 18.25 hrs. that some persons were loading two tractors with sand from the river bed of Darkeswar Rivernear Bastardih village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolleys of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Darkeswar River and fled away from the spot. We rushed to the tractors and detained the said two tractors. We searched the said tractors and found that the tractors are loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending tractors. Hence, seized the above noted tractors along with trolleys loaded with sand and brought to Kashipur PS. As there is every reason to believe that the driver and owners of the said tractors with ill motive were transporting sand illegally without any valid documents in support of carrying sand and doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted tractors along with the trolleys and unknown others for investigation.
