In producing herewith arrested accused person namely Shantiram Mahato(35), S/O-Rabindranath Mahato of village-Dhabani ,PS-Kenda, Dist- Purulia along with one seized Blue Mettalic colored YAMAHA FZ-X Motorcycle bearing Registration No- WB56S/4859.

I beg to report that today myself along with C/ 346 Shaktipada Rajak , HG- 1926 Bidhan Tantubai and HG- 1923 Banamali Manki all are of Kenda PS were performing Day mobile duty at Kenda Jamtal More under Kenda PS area vide Kenda PS C.C No- 934/22 dtd. 23.08.2022 and Kenda PS GDE No-709 dtd- 23.08.2022 at about 11:25 hrs, I found one Motorcycle bearing Registration No- WB56S/4859 coming from Kenda village side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated Sec. 279 IPC and I also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore, I pray that a specific case may kindly be start against accused Shantiram Mahato(35), S/O-Rabindranath Mahato of village-Dhabani, PS-Kenda, Dist- Purulia
