Sir,

In producing herewith the accused person namely Anil Ch Mahato (32 Yrs.), S/o- Ratan Mahato of Vill- Baram, PS- Arsha, Dist- Purulia along with seized article i.e. one Truck having Reg. No-JH 09U-0384, loaded with approx. 500 cft white stone.

The fact of the case in brief is that on 30/08/2022 I along with C/-922 Sanjoy Bauri, both of Kenda PS were performing Mobile duty. During mobile NVF- 159 Dhiren Hansda duty on 30/08/2022 at about 06.35 hrs. when we reached at Jamtal More found that the above noted Truck was coming from Manbazar side proceeded towards Purulia. On seeing the Police party driver of the said vehicle stopped his Truck in a distance and he tried to fled away after keeping the Truck near at Jamtal More but we manage to detain the driver of the said Truck. On demand the driver of the said Truck failed to produce any valid documents in respect of the said Truck as well as white stone. It is ascertained that the owner and driver of the said truck loaded the said white stone by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized one Truck having Reg. No-JH 09U-0384 loaded with approx. 500 cft white stone under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver of the said tractor after preparing memo of arrest duly signed by the accused driver. I also informed him regarding ground of arrest and arranged to inform his relatives. Thereafter arrange another driver from my source and brought the said truck at Kenda PS. So there have sufficient reason to belief that driver and owner of the said seized truck procured the said white stone by fraudulent means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the seized Truck having Reg. No-JH 09U-0384, loaded with approx. 500 cft white stone.
