MOST RESPECTFULLY SHEWETH:-

1. That the complainant is a permanent resident of the Purulia district
under Kotshila Police Station.

2. That the accused persons with malafide intention executed a registered Deed of Sale on 01.09.2014, being Deed No. 1997, in favour of the Complainant and transferred the property situated at Dist. Purulia, Mouza- Chitarpur (Kokarthap), R.S. Khatian No. 155, R.S. Plot No. 1913, measuring an area 6 decimal.
3. That it was a bolt from blue, when, the Complainant in March, 2022, received a Notice from Court, and became aware about a Civil matter, which has been instituted, by Dipali Mahato, wife of Ramjiban Mahato, and minor sons of Ramjiban Mahato, where name of the complainant appeared as one of the defendants.
4. That on further enquiry the Complainant came to know that the accused persons intentionally to cheat the complainant, fraudulently sold the said property in favour of Complainant by concealing the fact that the accused persons have executed and registered a Deed of Gift in favour of his two minor sons being no. 399 dated 12.02.2014.
5. That Ramjiban Mahato in connivance with his wife, Dipali Mahato, dishonestly and fraudulently executed the Deed of Sale in favour of Complainant.
6. That the Accused Person no 1 misrepresented that the said property belongs to him and dishonestly with intention to cheat the complainant, the said property was sold with a motive to extort Rs. 50,000/-.
7. That the Complainant is a victim of misrepresentation, dishonesty, cheating and fraud at the instance of the Accused Persons and when the Complainant approached Kotshila P.S. with a written complaint, the Officer-in-Charge refused to accept the Complaint and suggested the Complainant to take shelter of the Ld. Court.
8. That the Complainant thereafter submitted a written complaint through Registered Post, addressing to the officer-in-charge of Kotshila P.S., on 06.06.2022 but no F.I.R was lodged or necessary actions were taken against the said Accused Persons.
9. Furthermore, the Complainant submitted a written appeal to the Superintendent of Police, Purulia, (the received copy of the written appeal is annexed herewith). Nonetheless nothing fruitful happened.
10. That the instant complaint should be sent to the Officer-in-Charge of Kotshila P.S. u/s 156(3) Cr.P.C. for treating it as a FIR and to start a specific case against the accused persons, to unearth the unvarnished
