In producing herewith 01(one) arrested accd. person namely Paresh Rajwar (31 yrs) s/o Lt Dhiren Rajwar of vill.-Nutandi, PO-Barabendya, PS-Joypur, Dist.-Purulia along with seized one red colour tractor bearing registration no. WB55B/0782 (Chassis No. MBNABAEXPKJA04159, Engine No. NKA2EMJ0042) - model - Mahindra B 275 DI TU MKM DLX attached with trolley loaded sand 100 cft (approx) under proper seizure list, I beg to submit that today (04/08/2022) I along with (1) C/970 Dolan Biswas (2) C/982 Shyamal Rajwar both of Kotshila P.S were performing Evening Mobile duty vide Kotshila PS CC No. 1481/22 Date 04.08.2022. During my mobile duty at about 19.35 hrs I along with force reached on Purulia-Ranchi road near Jabragora more under Kotshila PS and found that one red colour tractor bearing registration no. WB55B/0782 named as 'Mahindra B 275 DI TU MKM DLX' attached with trolley loaded with sand was coming from Beradih side. On seeing the Police party near Jabragora more, the driver of the said tractor was trying to flee away. But after a hot chase, we could able to detain the driver of said tractor. I asked the driver Paresh Rajwar to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. During interrogation he confessed that he loaded the tractor with sand by illegal manner for selling the same to make profit by dishonestly for running clandestine business consent with the owner of the said tractor. So, I seized the tractor bearing registration no. WB55B/0782 (Chassis No. MBNABAEXPKJA04159, Engine No. NKA2EMJ0042) - model - Mahindra B 275 DI TU MKM DLX attached with trolley loaded with sand 100 cft (approx) under proper seizure list from 19.55 hrs to 20.15 hrs duly signed by police witnesses and I arrested the driver namely Paresh Rajwar (31 yrs) s/o Lt Dhiren Rajwar of vill.-Nutandi, PO-Barabendya, PS-Joypur, Dist.-Purulia at 20.25 hrs after issuing Arrest Memo and observe all legal formalities of arrest also informed him regarding ground of arrest. The said driver could not produce any driving license at the time of arrest. As such there is every reason to believe that the driver and owner of the tractor with ill motive are habitually dealing with sand illegally for selling the same to make profit by dishonestly for running a clandestine business without any valid document. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver namely Paresh Rajwar (31 yrs) s/o Lt Dhiren Rajwar of vill.-Nutandi, PO-Barabendya, PS-Joypur, Dist.-Purulia and owner of the tractor bearing registration no. WB55B/0782 (Chassis No. MBNABAEXPKJA04159, Engine No. NKA2EMJ0042) - model – Mahindra B 275 DI TU MKM DLX may kindly be started and arrange for its investigation.
