In producing herewith the following arrested accd. persons (i) Suraj @ Debashish Kumar (26 years) S/O- Lt Krishna Kumar of Vill- Belyadih, P.S- Kotshila, Dist.- Purulia (ii) Shahrukh Ali (24 years) S/O- Nantu Ali of Vill- Dangal, P.S- Kotshila, Dist.- Purulia (iii) Chiranjit Kumar (22 years) S/O Swapan Kumar of Vill- Bamnia PS Kotshila, Dist- Purulia, (iv) Sukram Mahali (19 years) S/O Budhu Mahali of Vill- Shyampur PS Kotshila Dist- Purulia and brought under seizure the following articles-(1) One Iron made "Bhojali" with wooden Butt, Total Length approx 14" out of which Iron portion 10" and Butt 04" (2) One Iron Pipe Length about 3'1" rounded 3". approx (3) one Axe with Bamboo butt which length of butt 2'8" and iron portion length 3 1/4 " (4) One iron cutter hacksaw length about 12" (approx) after preparing a seizure list duly signed by the witnesses as well as accd. persons. I do hereby lodge a written complaint against the above noted accd. persons and others to the effect that on 20/08/22 at 23:35 hrs ASI Tushar Kanti Mondal (Duty Officer) received information from creditable source that 10/11 criminals assembled in an open place on western side of the Talicentre to Simni road at Mantanr near Bidi Labour Hospital with a view to commit dacoity in the Bamnia Area. After getting such type of information ASI Tushar Kandi Mondal noted the fact in G.D. vide Kotshila P.S GDE No. 828 Date 20/08/22 and informed the matter to O/C, Kotshila P.S. and as per his direction I along with CAP524 Krishna Ch Mahato, C/983 Radhakanta Kisku Vide CC No. 1633/22 Date 21.08.2022 (CDE No. 829 Date 20.08.2022) and Night mobile Officer ASI Parimal Tewary and C/557 Ambuj Kr Mandal C/1543 Prabir Kr Mandal & HG/1774 Sadhan Kumar proceeded towards the Talicentre to work-out the said information. I alongwith officer and force reached nearby spot at 00.15 hrs (21.08.2022) and on keeping safe distance stop the vehicle by the side of the road and proceeded to the western side of the Simni road on foot and when we reached near the spot and found 10/11 persons sitting Northern side of the Bidi Labour Hospital at Mantanr and whispering each and others. We tried to apprehend them but seeing the police party they tried to flee away but on hot chase we able to apprehend the above noted 04 (four) accd. persons. On immediate search on their person recovered One Iron made "Bhojali" with wooden Butt, from the right hand grip of accd Suraj @ Debashish Kumar, and One Iron Pipe recovered from Shahrukh Ali and one Axe with Bamboo butt recovered from Chiranjit Kumar One iron cutter hacksaw recovered from Sukram Mahali. On being asked they disclosed their identity as noted above and on interrogation they disclosed that one Prasenjit Kumar S/O Sambhunath Kumar of Vill-Belyadih, PS- Kotshila Dist- Purulia and other persons who were unknown to them, but they fled away on getting the scent of police. On being asked they could not give any satisfactory reason for keeping the, Bhojali and other weapons to assemble the place at the dead hour of night. On interpation-they also-stated that they all assembled the to-commit house dacoity at the Bamnia village. I seized all offending weapons from 00.45 hrs to 01.25 hrs after preparing proper seizure list duly signed by the accd. persons as well as police witness as there are no such public witnesses was available at the dead hours of night. After that I arrested all 04 (four) accd. persons as noted above from 01.35 hrs to 01.50 hrs. Issued memo of arrest and inform them and their family members regarding ground of arrest. Observe all legal formalities of arrest as per guidelines of Hon'ble Apex Court.

So I, therefore, lodged a complaint against accd. persons namely (i) Suraj @ Debashish Kumar (26 yrs) S/O- Lt Krishna Kumar of Vill- Belyadih, P.S- Kotshila, Dist.- Purulia (ii) Shahrukh Ali (24 yrs) S/O- Nantu Ali of Vill- Dangal, P.S- Kotshila, Dist.- Purulia (iii) Chiranjit Kumar (22 yrs) S/O Swapan Kumar of Vill- Bamnia PS Kotshila, Dist- Purulia, (iv) Sukram Mahali (19 yrs) S/O Budhu Mahali of Vill- Shyampur PS Kotshila Dist- Purulia (v) Prasenjit Kumar S/O Sambhunath Kumar of Vill- Belyadih, PS- Kotshila Dist- Purulia and others for committing the offence U/S 399/402 IPC.
