Sir,

In producing here with 01(One) arrested accused person Rakesh Sharma (28 yrs) S/o Mahesh Sharma of H.No.1112, Bhuiyadih, Nannagar, Kanubhatta, PS-Sitgora, Dist-East Singbhum, Jharkhand along with seized Motor Cycle (Yamaha, FZ, Blue coloured) Bearing Reg. No.JH05CU/5700.

I beg to state that today i.e on 06.08.2022 in course of my evening mobile duty vide Manbazar PS GDE No.225 dt .06.08.2022 I had been to Jitujuri more at 18:15-18:35 hrs and found that the above noted person with his Motor Cycle Bearing Reg. No.JH05CU/5700 was coming from Manbazar side with excessive speed and rough driving in negligence manner without wearing protective head gear. Myself along with force signalled to stop him but the driver of the said Motor Cycle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him outside of Jitujuri more on Purulia-Manbazar under Manbazar PS. This rough and negligence driving of driver would lead to an accident at any time. Any passerby could be injured by such activities. On being asked the above aced. Person could not be able to give any satisfactory answer for that movement on road and public place by such rough driving. So I arrested him at 19:25 hrs for rough and negligent driving and disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, issued memo of arrest. On being asked he could not able to produce the valid documents in respect of said Motor Cycle as well as DL. So, I seized the said Motor Cycle (Yamaha, FZ, Blue coloured) Bearing Reg. No.JH05CU/5700 in between 18:45 hrs to 19:15 hrs after preparing seizure list duly signed by the witnesses.

So, a specific case may kindly be initiated against Rakesh Sharma (28 yrs) S/o Mahesh Sharma of H.No.1112, Bhuiyadih, Nannagar, Kanubhatta, PS-Sitgora, Dist-East Singbhum, Jharkhand as per law and arrange for its investigation.
