Sir,

In producing here with 01(One) arrested accused person Gour Sing Sardar (28 yrs) S/o Late Haradhan Sing Sardar of Vill-Mohandih, PS-Kenda, Dist-Purulia along with seized Motor Cycle (Passion Pro, Red-Black coloured) Bearing Reg. No. WB56G/3247.

I beg to state that today i.e on 16.08.2022 in course of my evening mobile duty vide Manbazar PS GDE No.621 dt .16.08.2022 I had been to Indkuri more side at 18:45 hrs and found that the above noted person with his Motor Cycle Bearing Reg. No. WB56G/3247 was coming from Pairachali side with excessive speed and rough driving in negligence manner without wearing protective head gear. Myself along with force signalled to stop him but the driver of the said Motor Cycle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him outside of Indkuri more near bypass on Manbazar-Purulia road under Manbazar PS. This rough and negligence driving of driver would lead to an accident at any time. Any passerby could be injured by such activities. On being asked the above accd. person could not be able to give any satisfactory answer for that movement on road and public place by such rough driving. So I arrested him at 19:15 hrs for rough and negligent driving and disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, issued memo of arrest. On being asked he could not able to produce any valid documents in respect of said Motor Cycle as well as DL. So, I seized the said Motor Cycle bearing Reg. No. WB56G/3247 (Passion Pro, Red-Black coloured) in between 18:45 hrs to 19:05 hrs after preparing seizure list duly signed by the witnesses.

So, a specific case may kindly be initiated against Gour Sing Sardar (28 yrs) S/o Late Haradhan Sing Sardar of Vill-Mohandih, PS-Kenda, Dist-Purulia as per law and arrange for its investigation.
