Sir,

In producing here with one accused person Bhaskar Singh (43) S/O Lt- Tarani Singh of village- Dhagara, PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 15 (Fifteen) Ltrs. ID liquor within a Plastic Jarikane and blader tube
- (2) 10 pieces plastic glasses

I S.I. Banshidhar Mukherjee of Manbazar PS do here by lodged a complaint against accused namely Bhaskar Singh (43) S/O Lt- Tarani Singh of village- Dhagara, PS- Manbazar, Dist- Purulia to the effect that today (18.08.2022) at 17:35 hrs. I received a telephonic information from a reliable source that one Bhaskar Singh (43) S/O Lt- Tarani Singh of village- Dhagara, PS- Manbazar, Dist- Purulia was stocked ID liquor illegally at his road side grocery shop and selling the same to hike price for his personal gain. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1353 Atanu Ganguly, C/601 Shyamlal Mandi rushed to the spot for raid by Govt. vehicle. At about 20:15 hrs. myself along with force reached at Dhagara village and held raid in the grocery shop of Bhaskar Singh and found that grocery shop owner selling ID liquor at his own grocery shop and Seeing the police party some persons fled away and said Bhaskar Singh tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly signed by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Bhaskar Singh (43) S/O Lt- Tarani Singh of village- Dhagara, PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
