
With due respect I, SI Abhijit Das, beg to submit before you that on 18/08/2022 at about 19:05 hrs while myself along with force 1) C/1327 Somik Banerjee and HG/1853 Ajanda Baskey were performing Naka duty vide Neturia PS GD No-850 Dated-18/08/2022 at Dishergarh ghat on Purulia-Barakar Road. I found one vehicle was coming from Barakar side towards Parbelia side with driving in excessive speed. Police personnel, present there in proper Police uniform raised hand and directed him to stop the vehicle but he violated the Police Signal and endangering human life by rash and negligently driving of the vehicle which may cause accident to the road user any time. After long chase we can able to apprehend him at Parbelia rail line. On interrogation he disclosed his identity as Raju Kumar Hela (31 Years) S/O- Santosh Kumar Hela of Vill-Sitalpur Colliery 4 No., PS-Kulti, Dist-Paschim Burdwan. On being asked he failed to produce any valid documents of the said vehicle. Hence he violated the provision of Section 279 IPC/184 MV Act. So, I seized the vehicle having Regd. No- WB 37C/2039 under proper seizure list duly signed by the witnesses and arrested the above noted offending driver avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court.

So, I pray before you that a specific case may kindly be registered against the accused driver Raju Kumar Hela (31 Years) S/O- Santosh Kumar Hela of Vill-Sitalpur Colliery 4 No., PS-Kulti, Dist-Paschim Burdwan (Driver of vehicle having Regd. No- WB 37C/2039) committing offence U/S-279 IPC/184 MV Act.
