Sub: Prayer for lodging F.I.R,

Sir,

In producing here with the arrested accused person namely Mantu Kr. Saw (40 Yrs) S/o Lt. Dhovi Saw of Vill- Dalpatti, PS- Jharia, Dist- Dhanbad (Jharkhand) along with below mentioned seized articles which are as follows:-

i) 3000 (three thousand) packets of Turkey Bijli Fire crackers and each packet contain 100 Pcs Fire crackers (approx), Gross weight 300 Kg (approx).

ii) 36 (Thirty six) Packets of 12 Star Fire & Sound crackers and each packet contain 01 (one) shell, gross weight- 26 Kg (approx).

iii) 36 (Thirty six) Packets of Sky Shot Fire crackers and each packet contained 03 (three) shells, Gross weight - 40 Kg(approx).

iv)36 (Thirty six) Packets of 1K Chain of Fire crackers and each chain contained 1000 (one thousand) fire crackers(approx), Gross weight - 33 Kg(approx).

v) 01 (One) Blue colour Tata ACE vehicle bearing Regd. No- JH10BZ/9156.

I beg to submit that on 20.08.2022 from 10.05 hrs, myself long with force C/23 Chandi Mukherjee, C/1117 Sadananda Mahato was performing Naka checking duty at Darda border under Para PS area on Chandakeyari- Raghunathpur road. This refers to Para PS GDE No 830 dtd 20.08.2022 & Para PS C.C. No.2244 dtd 20.08.2022. Then, I noticed at about 22.05 hrs that one Tata ACE vehicle having Regd. No- JH10BZ/9156 is coming from Chandankeyari side (SH-8) with high Speed which caused rush & negligent driving. We tried to stop the said vehicle. But, the driver did not pay any heed. There was every possibility of loss/serious injury of nearby public due to his such kind of rush driving. After a hot chase, We managed to stop him. Accordingly, we noticed that the vehicle is loaded with huge quantity to fire crackers which suppose to be prohibited fire crackers in totally uncovered and unsafe condition which may cause endanger to human life at any time as the fire crackers considered as inflammable articles. On being search, we did not found availability of any fire extinguisher in the vehicle as safety measures.

Being asked, he disclosed his identity as noted earlier and also he confessed that since long, he and the owner of the vehicle are possessing & selling these kinds of fire crackers at several places through this vehicle (mode of transport). Accordingly, I asked him to produce valid licence/ documents in respect of loaded fire crackers. But, he failed though sufficient time was given. Finding no alternative way, I have seized the above noted articles after prepared proper seizure list duly signed by the witnesses including labelling of sample copies and arrested him after prepared proper arrest memo.

Hence, I pray that a specific case may kindly be initiated against the above noted arrested accused person and against the registered owner of seized vehicle under proper sections of law and arrange for its investigation.
