Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Amar Duary (32 yrs ) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha, District- Purulia with seizure of 18 pcs. Sealed bottles of "DIL Se" country spirit containing 600 ml. each which were seized and labeled under proper seizure list. I beg to submit that today (16.08.22) at 19.45 hrs while myself along with C/1260 Sontosh Soren and C/752 Durjodhan Sing Sardar vide Puncha PS CC No-1960/22 Dated 16.08.2022 were performing evening mobile duty at Poradih side. During evening mobile duty received source information that one Amar Duary (32 yrs ) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha, District-Purulia has illegally stocked liquor in his shop Tusugoria more under PS-Puncha & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Tusugoria more to work out the information after reaching at Tusugoria more and held raid in the shop of Amar Duary (32 yrs) S/O- Lt. Niranjan Duary of Vill- Poradih PS-Puncha, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand Amar Duary failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested and also 18 pcs. Sealed bottles of "DIL Se" country spirit containing 600 ml each which were seized under proper seizure list duly signed by witnesses and labeled out of which 01 (One) bottle "DIL Se" collected as a sample at the time of seizure the same and labeled under proper seizure list duly signed by witnesses as well as one of the same bottle is taken as a sample which is sealed and labeled. After seizure I arrested the accd Amar Duary as he committed offence u/s 46 A(c) B.E. Act 1909. During arrest the ground of arrest was duly notified, issued arrest memo and handed a copy of the same to arrestee. I also issued check list U/S-41 (1)(a), (b) (I), (II) Cr.P.C. Direction of the Supreme Court of India vide Criminal Appeal No.-1277 of 2014, Spl. Leave petition.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against the arrested Amar Duary (32 yrs ) S/O- Lt. Niranjan Duary of Vill-Poradih PS-Puncha, District- Purulia under proper section of law.
