Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Tapan Paul S/O- Lt. Romhari Paul of Village- Datarajih, P.O- Choto Sagen, P.S.- Puncha, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 25.08.2022 at about 4.20 PM I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Sri Tapan Paul, S/O- Lt. Romhari Paul of Village- Datarajih, P.O- Choto Sagen, P.S.- Puncha, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisedly by direct hooking from WBSEDCL LT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

out of which we seized the following -

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 4.30 PM on dated 25.08.2022. The accused person has committed an offence U/S 135(1)(a) of the Electricity ACT 2003 (Amendment) Act-2007.
