Sub: Prayer for starting a specific case against one Bipadtaran Munda (23yrs), S/O- Sripati Munda of vill-Balikhun, PO-Kundhurka PS-Puncha, Dist-Purulia (Rider of Hero Super Splendor Motor Cycle having Reg.No.-WB56T-1925).

Respected Sir,

With due respect I Sujoy Kundu, beg to submit before you that on 06/08/2022 at about 10.05 hrs while myself along with ASI Anup Roy, C/1260 Santosh Saren & C/752 Durjodhan Sing Sardar were performing naka checking at Dhadki more on Manbazar-Lalpur pitch Road under Puncha PS vide Puncha PS CC No-1899 Dated-06/08/2022. During naka checking I found one Motor Cycle having three persons (a rider and two pillion riders) was coming from Manbazar side towards Lalpur dangerously with excessive speed without wearing Helmet. We raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rash and negligently driving the Motor Cycle which may cause accident to the road user any time. Somehow we were able to apprehend him. On interrogation they disclosed their identities as Bipadtaran Munda (23 yrs), S/O- Sripati Munda of vill-Balikhun, PO-Kundhurka PS- Puncha, Dist-Purulia (Rider of Hero Super Splendor Motor Cycle having Reg.No.-WB56T-1925) and Rupchand Mudi (19yrs) S/O-Lt Jaleswar Mudi of vill-Dhulatapi PO-Dighi PS-Hirbandh Dist-Bankura & Gouranga Kara (32yrs) S/O-Sarat Ch. Kara of vill-Keleardih PO-Pirorgoria PS-Manbazar Dist-Purulia pillion riders of the said motor cycle.

Hence on being asked Bipadtaran Munda, driver of the said motorcycle unable to produce his driving license and RC book of the said motorcycle. So he committed offence U/S 279 IPC read with section 181/184/192/194C/194D MV Act 1988 read with MV (Amendment) Act, 2019.

So I seized the said Hero Super Splendor Motor Cycle having Regd. No- WB56T-1925 from the possession of above noted rider of the said motor cycle namely Bipadtaran Munda under proper seizure list duly signed by him and other available witnesses and arrested the offending driver namely Bipadtaran Munda (23yrs), S/O- Sripati Munda of vill-Balikhun, PO-Kundhurka PS- Puncha, Dist-Purulia, abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bailable I offered him bail but none were turn up before me. On being asked he refused to undergo to medical check up. So finding no other any alternative way I brought him into PS along with seized articles.

So, I pray before you that a specific case may kindly be registered against the accused namely Bipadtaran Munda (23yrs), S/O- Sripati Munda of vill-Balikhun, PO-Kundhurka PS- Puncha, Dist-Purulia (Rider of Hero Super Splendor Motor Cycle having Reg.No.-WB56T-1925). under proper section of law.
