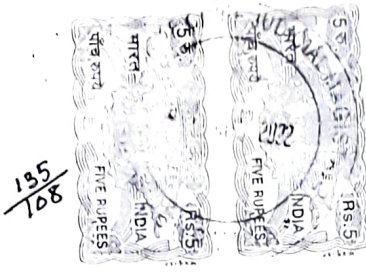

Most respectfully sheweth:-

- 1) That on 18.05.2022 at about 03.00 P.M. when the complainant was looking after and taking care of the land having its plot no. 711 within mouza Lagda so situated beside Purulia- Ranchi road at Lagda more Village & P.O.- Lagda, P.S.- Purulia (M), District- Purulia under the ownership & possession of the father of the complainant accused no. 1 to 5 farming an unlawful assembly with Lathi, iron rod, shovel, Gad & gaiti gheraoed the complainant all of a sudden and started hurling filthy and defamatory languages aiming at your petitioner out of previous grudge.

2) That naturally the complainant/petitioner requested them for becoming came and quiet but on the contrary the accused persons became more arrogant and violate and disclose that either your petitioner and his father would have to relinquish their right, title interest and possession over the land as mentioned above or they would have to give the accused person a sum of Rs. 1500/- (Rupees one thousand five hundred) as "Mastan Tax" otherwise they would kill him. Your petitioner thus then raised protest against such act extortion putting a person in fear of death. The accused no.4 then suddenly inflicted forceful blow of first on eye of your petitioner who prior to understand anything, received assault of lathi on his person so inflicted upon him by the accused no.2 and consequently your petitioner fell down on the earth and started groaning in unbearable pain. The accused no.5 with the help of his leg then pushed your petitioner forcefully towards earth and under the instruction of accused no.1 accused person no.3 inflicted the blow of iron road in his head on the head of your petitioner/complainant with an intent to kill him.



3) That the complainant received bleeding injuries on his head and become semi-conscious, the accused then thought that the complainant succumbed to him injury and the accused persons the then left the place of occurrence. Subsequently thereafter when the inmates of the petitioner/complainant received the information, they rushed to the P.O. and with the help of local people took him to Deben Mahato Medical College & Hospital where he got admitted. The attending medical officer so attached to the said medical institution on the relevant date and time dressed your petitioner's wound in the O.T. with many a stitches. More so nodular calcification was also seen in the left frontal region (S/O calcified granuloma) of the complainant. Such sort of grievous injuries so sustained on the vital part of the person of your petitioner might be the cause his death. However with the blessings of of almighty and due to prolonged treatment and medical supervision your petitioner somehow or other survived. But still he is under treatment.

4) That your petitioner is still under treatment, but the complainant after being little fit to move had been to the Purulia (M) P.S. time & again with a written complainant depicting inter alia all the real scenario what happened wrongfully upon him with a prayer for setting the Law in motion, but neither he was allowed to meet the O/C nor the Police Personnel did accept his latter of complaint.

- 5) That your petitioner then sent his letter of complaint under registered cover with A/D addressing the O/C Purulia (M) P.S. but then too no step was taken towards institution of any specific case so that the accused persons be prosecuted and punished.
- 6) That due to such inaction on the part of the police personnel of the concerned P.S. your petitioner informed the matter in writing to S.P Purulia on 20.06.2022, but unfortunately the District Police Administration still turned deaf ears to the same and no specific case has yet been instituted.
- 7) That search and seizure is very much warranted in the instant case and your petitioner is a very poor and rustic person heaving no such annual income for incurring expenses of a complaint case.



In light of the above it is therefore prayed that Your Honour may graciously be pleased to forward the instant petition of complaint to the Inspector in charge of Purulia (M) P.S. with a direction upon him to investigate into the case treating the same as F.I.R under the provisions contemplated under sections 156(3) Cr.P Code.
