Sub: Complaint against Ranjit Sengupta.
Sir,

In producing herewith one arrested accd. person namely Ranjit Sengupta (19) S/O Sushil @ Pravarakar Sengupta of Vill-Balarampur, PS- Purulia (M), Dist- Purulia with seizure list and seized articles.

I beg to submit that today (14.08.2022) while I was detailed to perform Spl. mobile duty in PS area along with force i) C/2735 Soumen Nayak & ii) NVF/363 Hemanta Kumar both are Purulia (M) PS & Purulia (M) PS C.C. No 3094 Dt. 14.08.2022 and GDE No 775 Dtd. 14.08.2022. During my mobile duty, I received a secret tip off that an illegal possession of huge quantity of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot at Balarampur village More and after arriving at the spot and as per your instruction conducted raid in the Grocery shop which is styled as "Durgarani Grocery Shop" of Ranjit Sengupta under this PS at about 18:50 hrs. During the raid 2/3 persons fled away near the shop and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he procured and stock the Country spirit for selling illegally from his shop so that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit at his shop. Subsequently, I seized **15 (fifteen) sealed bottles Dil Khush country sprite each containing 600 ml. containing one plastic bag. In which kept 01 sealed bottles as sample. I seized the same** under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Ranjit Sengupta (19) S/O Sushil @ Pravarakar Sengupta of Vill-Balarampur, PS- Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his shop. Under the fact and circumstance kindly take necessary lawful action against Ranjit Sengupta (19) S/O Sushil @ Pravarakar Sengupta of Vill-Balarampur, PS- Purulia (M), Dist- Purulia.
