## Respected Sir,

In producing herewith one arrested accused, person namely Sadhu @ Dipak Kr. Mahato (37) S/O Lt. Khandulal Mahato of Vill- Sitalpur, Uparpara, PS- Purulia (M), Dist- Purulia with seizure list and seized articles.

I beg to submit that today (16.08.2022) I was detailed to perform Special mobile duty in PS area along with force i) C/1464 Bhagyadhar Patra & ii) NVF/363 Hemanta Kumar both are of Purulia (M) PS vide Purulia (M) PS C.C. No 3108 Dt. 16.08.2022 and GDE No 845 Dtd. 16.08.2022. During my mobile duty, I received a secret tip off regarding an illegal possession of huge quantity of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot at Sitalpur village and after arriving at the spot and as per your instruction conducted raid in the house of Sadhu @ Dipak Kr. Mahato under this PS at about 15:35 hrs. During the raid 2/3 persons fled away near the shop and detained one person. On asking the identity he disclosed his name and address as noted earlier. On interrogation he confessed that he procured and stock the Country spirit for selling illegally from his house so that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit from his shop. Subsequently, I seized 19 (nineteen) sealed bottles "Dil Se" containing 600 ml country spirit in each bottles contained in a plastic bag from which I kept 01 sealed bottles as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Sadhu @ Dipak Kr. Mahato (37) S/O Lt. Khandulal Mahato of Vill- Sitalpur, Uparpara, PS- Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his dwelling house. Under the fact and circumstance kindly take necessary lawful action against @ Dipak Kr. Mahato (37) S/O Lt. Khandulal Mahato of Vill- Sitalpur, Uparpara, PS- Purulia (M), Dist-Purulia.
