Sub: Prayer for lodge F.I.R

Respected Sir,

I, Shri Sekhar Kr. Mitra, Inspr. of Police, DEB Purulia do here by lodge a written complaint against Jadab Nandi (46) S/o- Lt. Manik Nandi of Vill- Sidpur, PS- Purulia (M), Dist- Purulia along with following seized articles which were seized from the possession of Jadab Nandi (46) S/o- Lt. Manik Nandi of Vill- Sidpur, PS- Purulia (M), Dist- Purulia.

- 1) PDS Rice-21(Twenty one) Basta in sealed condition weight total- 1,022 kgs 500 gms (Approx)
Engraved over basta" Bharatiya Khadya Nigam" (Hindi Version). Food grains,Commodity RICE/WHEAT, Food Corporation of India.
- 2) PDS Rice -81 (Eighty one) Basta without sealed weight total 3,945 kgs 400 gms (Approx)
- 3) PDS Wheat 01 (One) Basta sealed condition, weight total 50 kgs (Approx)
- 4) PDS Wheat 08 (Eight) Basta without sealed condition, weight total 394 kgs 200gms (Approx)
- 5) PDS Atta-02 Basta(Two) sealed condition, weight 47kgs 500 gms Per Basta, Total-95 Kgs(Approx)
- 6) 01 (one) Pice Digital weighing scale, 'Goldline', Maximum Wt-80/200 Kgs.

to the effect that today on 27.08.2022 on the basis of secret and credible source information I, Shri Sekhar Kr. Mitra, Inspr. of Police, DEB Purulia along with ASI Swapan Chakraborty, C/- 88 Pradut Kumar Mondal, HG/- 1427 Benimadhab Char all of DEB, Purulia had been to the Purulia (M)PS and submit a requisition to I.C Purulia (M) PS for rendering assistance, the said credible information noted at Purulia (M) PS at 12.15 hrs vide Purulia (M) PS GDE no. 1356 dated 27.08.2022. Thereafter, SI Sanjib Kumar Sen and force of Purulia (M) PS and myself along with my team of DEB Purulia left for Sidpur under Purulia (M) PS to work out the above noted information by availing Govt. vehicle bearing No- WB 56M/ 8203. On arrival at Sidpur Village and the said information has been work out by two local peoples viz (1) Rabin Paramanik S/o Gour Paramanik (2) Ujjal Paramanik S/o- Sripati Paramanik Both of Vill- Sidpur, P.O- Hutmura, PS- Purulia (M), Dist- Purulia, they assist us for holding raid, search and seizure in the Paddy shop of Jadab Nandi (46) S/o- Lt. Manik Nandi of Vill- Sidpur, PS- Purulia (M), Dist- Purulia. Thereafter myself along with accompanied officers and force and with the active assistance of above noted two local witnesses held raid in the Paddy shop of Jadab Nandi after observing all formalities as laid down in Section 100 of Cr.PC 1973 relating to search & seizure. Prior to hold raid in the Paddy shop we noticed huge number of PDS Rice, Atta and wheat staged inside the Paddy shop of the above noted accused person along with apparatus which is used for illegal selling. The shop owner namely Jadab Nandi asked to produced valid documents / license for running their such illegal business in respect of possessing PDS Rice, Atta and wheat but the shop owner failed to produce any valid documents/ license for running such illegal business. As such I seized the articles as mentioned above and in the seizure list No 1&2 in presence of local witnesses and Police witnesses under proper seizure list from the shop of Jadab Nandi and the accused put their signature on the seizure list.

As the shop owner failed to produce any valid documents/ license for running such illegal business, hence he violated provisions laid down in Para 7 of rule 3 of West Bengal. Thus he committed an offence punishable U/S- 7 (1)(a)(ii) of E.C (X) of Act 1955 against the shop owner Jadab Nandi accordingly.

In course of local enquiry it revealed that the above noted accused person is running clandestine business of PDS goods since long without having any authority or license and only for causing their wrongful gain and deprived poor local consumers/customers as well as causing loss of revenue to the Govt.



I therefore request you to start a case U/S 7 (1)(a)(ii) of E.C (X) of Act 1955 against the accused person named Lt. Manik Nandi (46) S/o- Lt. Manik Nandi of Vill- Sidpur, PS- Purulia (M), Dist- Purulia



As per kind direction of S.P DEB Purulia the case will investigate SI Amaresh Das of DEB, Purulia.


