





- 1) That, the complainant is the permanent resident of the above noted address and on 06/05/2022 when she was going to near Sarap Bandh at that time due to previous enmity all the above noted accused persons assaulted her with lathi, bhojali, bricks as she was alone, when she make halla than Dhiren Gope, Dilip Gope and Ambika Gope came there and they witnessed the incident and on seeing them the accused persons ran away.
- 2) That, due to such incident she fall down on the earth and she sustained grievously injuries on her head and on her ear and it's make difficulties to hear properly and on the other parts of her body, she was hospitalized at Deben





Mahata Govt. Medical college & hospital at Purulia from 06/05/2022 to 13/05/2022 and in the injury report there is note that she was physically assaulted, the C.T scan was done at Modern Pathology at Purulia.

- 3) That, on the particular date she informed the police of the Purulia(M) police station but the police sent her at the hospital by saying that first go and save your life, after discharge she again went to Purulia(M) police station but the police did not took her written complaint, so the petitioner is bound to inform the matter to the Superintendent of police at Purulia.
- 4) That, the complainant is filling the Xerox copies of the letter which was informed to the Superintendent of police, treatment ticket etc.
- 5) That, the accused persons are very dangerous in nature and they are threatening the complainant with dire consequences by saying not to depose elsewhere against him otherwise they will murder her, so there is every chance of loss of life of the complainant, and the accused persons are very adamant to cause hurt etc.

Hence it is prayed that your Honour may graciously be pleased to sent the complaint to officer-in-charge at Purulia(M) to treat the same as F.I.R and to investigate the matter U/S 156(3) Cr.P.C.
