Sir,

In producing herewith one arrested accd. person namely Nivas Mandal (40 yrs) S/O Bhuban Mandal of Vill- Chirumacha, PS- Purulia (M), Dist- Purulia with seizure list and seized articles.

I beg to submit that today (02.08.2022) while I was detailed to perform mobile duty in PS area along with force i) C/624 Pradip Chakraborty ii) HG/1618 Haripada Gorain Purulia (M) PS & Purulia (M) PS C.C. No 2947/2022 Dt.02.08.2022 and GDE No 72 Dtd. 02.08.22. During my sudden Naka checking at Bhangra battola as per order of I/C Purulia (M) PS detained one person carrying country sprite (Dil Khush). During interrogation he did not produce any valid documents in r/o carrying country sprite. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he selling illegally the country sprite (Dil Khush) among Bhangra villagers and adjacent area so that he could gain more amount from the selling of (liquors) Country Spirit. Subsequently, I seized 16 (Sixteen) sealed bottles country sprite (Dil Khush) each containing 600 ml. In which kept 01 sealed bottles as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person namely Nivas Mandal (40 yrs) S/O Bhuban Mandal of Vill- Chirumacha, PS- Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his house. Under the fact and circumstance kindly take necessary lawful action against Nivas Mandal (40 yrs) S/O Bhuban Mandal of Vill- Chirumacha, PS- Purulia (M), Dist- Purulia.
