1.---That the complainant and present accused persons No. 1 and 2 are the residents of village Ramdih, P.O. Arjunore, P.S.Purulia (M), Dist.Purulia (W.B.)

2.---That the present complainant is a physically Handicap person. He has got a building over R.S.Plot No.37 of mouza- Karcha Kuli J.L.No.158 under R.S,Khatian No.36 under P.S.Purulia (M), District Purulia within the jurisdiction of this Hon'ble Court.

3.---That During Revisional Settlement Operat\_ion the aforesaid R.S.Plot No.37 has been recorded in the name of grand father of the Complainant namely Banamali Duary. Said Banamali Duary constructed a double stored Building over R.S.Plot No.37. Said Banamali Duary possessed the said building by residing there with his family till his death. Banamali Duary died leaving behind his only son Hariram Duary as his only legal heir and representative. After the death of Banamali Duary,Hariram Duary inherited the said building and came into physical possession and possessed the same till his death. making an unlawful assembly with greivous weapons along with Gaiti, Sabzal, ~~xx~~ Iron rod etc. illegally and forcible after breaking the door entered into the Home of the complainant and started broken down the roof of the 1st floor of building of the complainant. Complainant and his witnesses requested ~~tham~~ not to broke the roof of the building. But they did not heard the solemn request of the complainant, they totally damaged the roof of the building for which present complainant sustained loss of Rs.7,00,000/- (Rupees Seven Lakh) Accused persons No.1 and 2 also threatened to kill the complainant ~~and assaulted him by fists and legs~~.
