Sir,

In producing here with arrested accused persons namely (1) Sk. Babu (35 yrs) S/O- Sk. Ali Hussain of Katin Para, P.S- Purulia (T), Dist- Purulia , A/P- Vill- Hijuli, PS- Hura, Dist- Purulia, (2) Tufan Das (41 yrs) S/O- Late Shyamapada Das of Alangidanga, Ward No- 01, PS- Purulia (T), Dist- Purulia, A/P- Sufal Pally, P.S- Purulia (M), Dist- Purulia and (3) Rajesh Roy @ Kochu (34 years) S/o Late Bablu Roy of Santi Pally Ward No-21, PS- Purulia (T), Dist- Purulia and seized articles (1) One sword with wooden butt length approx 33 ½ inch out of which 29 inch sharpen portion and 4 ½ inch butt (2) One Iron made Rod length 44 inch , (3) One Bhojali with wooden Butt length 12 ½ inch out of which 08 ½ inch sharpen portion and 4 inch wooden butt lodged complaint against them and 02 others to the effect that on 07.08.2022 at about 22.15 hrs received a credible tip that a gang of dacoits being armed with deadly weapons assembled at Khejuradanga Siyal Kheda Math, Ward No-16 and they were preparing themselves for committing dacoity at Dhobghata. Accordingly I informed the matter to I/C Purulia (T) PS over phone and contacted with all night patrolling officers, briefing to all I immediately along with source and (1) C/254 Karunamoy Bauri , (2) C/1189 Suchand Hansda (3) C/2962 Ujjal Mahanti, vide Purulia (T) PS C.C. No. 1991/22 dated- 07.08.2022 and GDE No- 403 dated- 07.08.2022 left to work out the information by a Govt. vehicle, and reached near Dhabghata Hari Mandir at 22.25 hrs leaving the Police vehicle No. WB 56C 5421 and started to proceed for the anticipated place on foot. At 22.35 hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that a gang of 10/12 persons assembled at Khejuradanga Siyal Kheda Math and those persons were whispering from which it was clear that they were preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed to ours words and tried to flee away. We succeeded to nab in rounding up only 03(three) of them at 22.45 hrs while the rest were managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them that we want to search them and if necessary they can search us, but they informed us that they are not willing to search us. Then after observing all formalities I searched the above noted apprehended persons and recovered (1) One sword with wooden butt length approx 33 ½ inch out of which 29 inch sharpen portion and 4 ½ inch butt from the possession of Sk. Babu , S/O- Sk. Ali Hussain (2) One Iron made Rod length 44 inch from the possession of Tufan Das (3) One Bhojali with wooden Butt length 12 ½ inch out of which 08 ½ inch sharpen portion and 4 inch wooden butt from the possession of Rajesh Roy @ Kochu .Then on 07.08.22 in between 22.55 hrs to 23.15 Hrs from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities I, seized (1) One sword with wooden butt length approx 33 ½ inch out of which 29 inch sharpen portion and 4 ½ inch butt (2) One Iron made Rod length 44 inch , (3) One Bhojali with wooden Butt length 12 ½ inch out of which 08 ½ inch sharpen portion and 4 inch wooden butt under proper seizure list as well as labeled duly signed by the apprehended persons and witnesses as Alamat property in c/w above case. Then from 23:20 hrs to 23:30 hrs I arrested 03 (three) persons namely (1) Sk. Babu (35 yrs) S/O- Sk. Ali Hussain of Katin Para, P.S- Purulia (T), Dist- Purulia , A/P- Vill- Hijuli, PS- Hura, Dist- Purulia, (2) Tufan Das (41 yrs) S/O- Late Shyamapada Das of Alangidanga, Ward No- 01, PS- Purulia (T), Dist- Purulia, A/P- Sufal Pally, P.S- Purulia (M), Dist- Purulia and (3) Rajesh Roy @ Kochu (34 years) S/o Late Bablu Roy of Santi Pally Ward No-21, PS- Purulia (T), Dist- Purulia. Issued Memo of arrest and observe all legal formalities of arrest, also inform them regarding ground of arrest and inform to their family members. On interrogation they confessed their guilt and they stated that they have assembled there along with associates namely Sahid Ansari @ Chotu, S/O Lt- Monir Ansari of Doctor Danga, Near Youth Club Ward no 15 P.S- Purulia Dist- purulia and Sk. Ramjan S/O Sk Nasib of Kalandar Danga, Ward No- 15 P.S- Purulia Dist- Purulia and others for committing house dacoity at Dhobghata.

I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity armed with deadly weapons which might be dangerous for life of public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested them preparing arrest memo and ground of arrest were duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely (1) Sk. Babu (35 yrs) S/O- Sk. Ali Hussain of Katin Para, P.S- Purulia (T), Dist- Purulia , A/P- Vill- Hijuli, PS- Hura, Dist- Purulia, (2) Tufan Das (41 yrs) S/O- Late Shyamapada Das of Alangidanga, Ward No- 01, PS- Purulia (T), Dist- Purulia, A/P- Sufal Pally, P.S- Purulia (M), Dist- Purulia and (3) Rajesh Roy @ Kochu (34 years) S/o Late Bablu Roy of Santi Pally Ward No-21, PS- Purulia (T), Dist- Purulia along with associates namely Sahid Ansari @ Chotu, S/O Lt- Monir Ansari of Doctor Danga, Near Youth Club Ward no 15 P.S- Purulia Dist- purulia and Sk. Ramjan S/O Sk Nasib of Kalandar Danga , Ward No- 15 P.S- Purulia Dist- Purulia and others under proper section of law.
