The fact noted in General Diary vide Purulia (T) P.S GDE No-485 Dated-09.08.22 and as per instruction of I/C Purulia (T) PS I SI Tufan Kumar Dawn along with Force (1) C/2962 Ujjwal Mahanti (2) C/11 Kajal Kumar Mukherjee (3) C/3006 Prasanta Malla, (4) C/1429 Jagadish Chnadra Mahato left for work out the information Vide Purulia (T) PS C.C No- 67/22 dated 09.08.22.

Today 09.08.22 on the day of Muhharam, Tikiya Para Akhara Committee bring out a procession from Post office more to Tikiyapara via Namopara, Radhakrishna More, Old Police Line, Hattola as per their licence Route (Licence No-19/22, Dated-05.08.22). several members participate in their religious procession, but when the Procession reached near Nilkuthidanga Durga and Sitala Mandir at about 08:30 Hours the above noted two persons of Tikiya Para Akhara Committee shows Fire arms in that procession that leading to panic among people and as well as the society and they also disobedience to order duly promulgated by the public servant. That's violets the Rules of the Licence by the Tikiya Para Akhara Committee. Collect information and identified the Akhara committee and (1) Sk. Arman, (20 Years) S/O- Sk. Vutu and (2) Bishal Ruhidas, (19 Years) S/O- Gopal Ruhidas both of Tika Para, Munsefdanga, Ward No-02, P.S- Purulia (T), Dist- Purulia persons noted above and I arrested the accused persons observing all legal formalities as laid down by Honble Supreme Court from Upen Babu Lane, near Prahlad Bouri Shishu Udyan, Munsef danga, P.S- Purulia (T), Dist- Purulia.
