

The humble petition on behalf of the complainant namely Ajay Paramanik.


Most respectfully begs to state as follows:

- 1. That the complainant is the permanent resident of the above noted address and under jurisdiction of this Ld Court.
- 2. That on 30/06/2022 at about 10.30 a.m. at Bhatbandh when the complainant was standing in a queue with an empty jar for filling tap nowater at that moment accused suddenly used filthy language and on the spur of the moment he hit his(complainant) head with a brick as a result complainant fell down and bleeding profusely with severe injury and senseless, thereafter the accused person tried to kill the complainant by sitting on his chest and holding his throat.
 - 3. That thereafter some people rescued him and took him to the Purulia Deben Mahato Sadar Hospital for necessary treatment but the Doctor on duty quickly admitted him to stop the bleeding and to restore sense.

- 4. That the accused person assaulted the complainant and due to such incident complainant received grievous head injury.
- 5. That the complainant was discharged from the hospital and the documents are attached with the petition.
- 6. That the complainant went to Purulia Town Police station but the official on duty did not accept the complaint.
- 7. That not getting any action from I.C Town P.S. informed the Superintendent of Police but same result from the side of the concerned authority.(copy annexed)
- 8. That the accused person is very dangerous in nature and anti social and he also threatening the complainant by saying not to depose anywhere against him otherwise he will murder him so there is every chance of loss of life of the complainant.

It is therefore prayed that your Honour may graciously be pleased to forward the complaint petition to I/C Purulia(Town)P.S to treat this petition same as F.I.R and to investigate the matter under section 156(3) Criminal Procedure Code and submit the report before the Ld Court.
