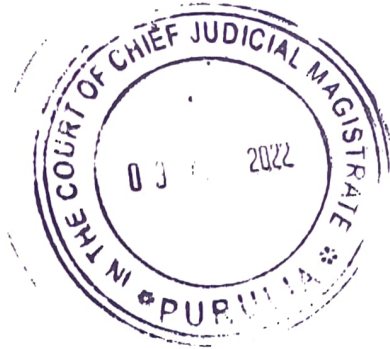

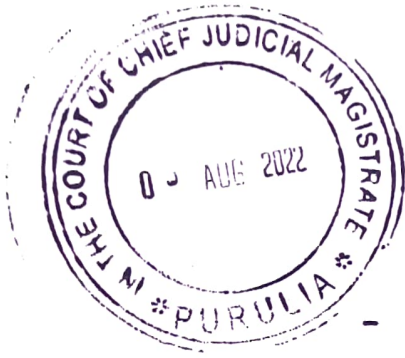

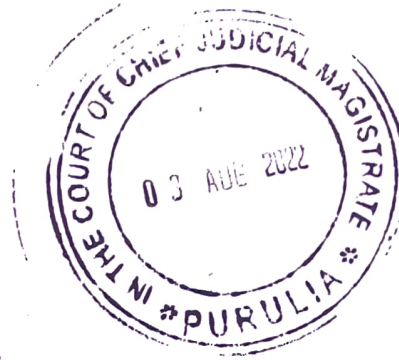

3. Special Land Acquisition officer Purulia .

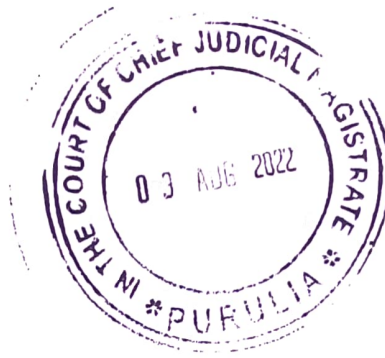
The above named complainant

Most respectfully begs to state as follows :-

- 1) That the complainant and the accused persons are the resident of Purulia , Municipality ward No. 20 , P.O. , P.S. and District Purulia and they are known to each other very well .
- 2) That on 30.6.2003 father of the complainant died leaving behind four sons namely Nirmal Nandi, Mihir Nandi, Asit Nandi, Muruli Nandi , and three daughters namely Mithila Dutta , Kalpana Rakshit, Manju Dey as his legal heir and representatives .
- 3) That Gour chandra Nandi father of the complainant left some property out of which 36 decimal R.S. Plot No. -1187 , and 1188 at Mouza Chharra has been acquired by the Government and a compensation amount has been sanctioned in the name of Gour chandra Nandi but it is very much curious that the said compensation amount has been withdrawn on 28.10.2021 by the about noted accused person by submitting a forged document before the concerned authority which they very well knew it the forged document but use it as genuine for the purpose of cheating and there by dishonestly induces the authority concern to disburse the compensation amount to the complainant .
