In producing herewith the arrested accused persons namely (1) Sadhan Gorain (42 yrs) s/o- Gurupada Gorain of Bhatbandh Mahato Para, Ward No. 03, PS- Purulia (T), Dist-Purulia, (2) Bharat Gorain (55 yrs) s/o Late Khedan Gorain of Nimtard, Ward No- 05, PS- Purulia (T), Dist-Purulia (3) Sk. Kamal (35 yrs) s/o- Lt. Sk. Azim of Bhatbandh, Kamar Para, Ward No- 04, PS- Purulia (T), Dist- Purulia along with seized articles like (1) Total Board Money amounting to Rs. 1120/- (08 Nos. of 100 rupee note, 06 No's of 50 rupee note and 2 No's, of 10 rupee note), (2) 25 number of Playing Cards, (3) 02 Pc half burnt candle, (4) 04 No's of Old Bengali News Papers and (5) 01 (one) used matches box.

I beg to report that on 12.08.2021 at 22:05 hrs SI Jayanta Maji along with C/2962 Ujjwal Mahanti, and C/586 Bholanath Dey was performing 1st Night Mobile Duty at Purulia (T) PS area. During said duty I received secret information that one gambling with huge amount was going on at Bharati Sangha Club at Bhatbandh Para, Ward No- 04 under Purulia (T) PS. Informed the matter to I/C Purulia (T) PS. Accordingly, as per order of I/C Purulia (T) PS I along with force left for Bhatbandh Para to work out the information. At about 22:25 hrs we reached at spot and very slowly cautiously approached towards where the gambling was reportedly going on and found that 03 (three) persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my associates staffs to cordon the place and within a moment the place was cordoned by police party. We disclosed our identity and then try to flee away but we were able to apprehend the above noted persons. Then, I requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels and mobile phones. After that we asked their identity and the persons disclosed their name and address as noted above. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash for wrongful loss to one and wrongful gain to another. After that in presence of witnesses (1) Total Board Money amounting to Rs. 1120/- (containing 08 Nos. of 100 rupee note, 06 No's of 50 rupee note and 2 No's, of 10 rupee note), (2) 25 number of Playing Cards, (3) 02 Pc half burnt candle, (4) 04 No's of Old Bengali News Papers and (5) 01 (one) used matches box seized under proper seizure list duly signed by the available witnesses in between 22:35 hrs to 22:50 hrs.

As such for committing offence punishable US 3 & 4 of WB.G. & P.C. above noted 03 (three) persons were arrested, issuing arrest memo and inspection memo in between 22:55 hrs to 23:05 hrs.

Therefore I pray before you that one specific case may kindly be started under proper section of law against the arrested accused persons namely (1) Sadhan Gorain (42 yrs) s/o- Gurupada Gorain of Bhatbandh Mahato Para, Ward No. 03, PS- Purulia (T), Dist-Purulia, (2) Bharat Gorain (55 yrs) s/o Late Khedan Gorain of Nimtard, Ward No- 05, PS- Purulia (T), Dist- Purulia (3) Sk. Kamal (35 yrs) s/o- Lt. Sk. Azim of Bhatbandh, Kamar Para, Ward No- 04, PS- Purulia (T), Dist- Purulia
