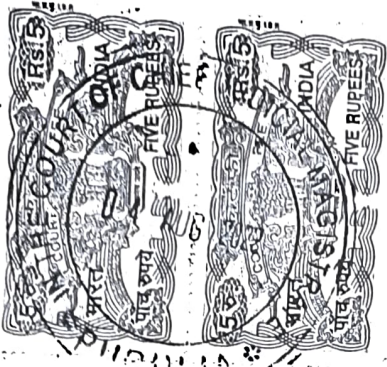

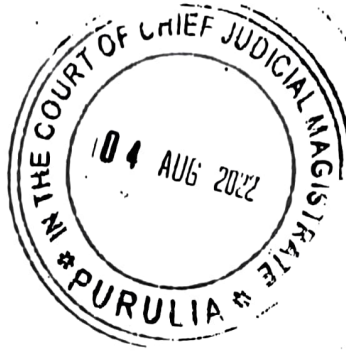

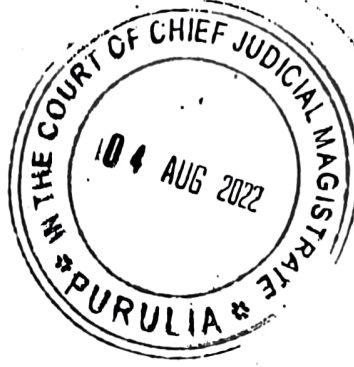

2...That on 18.07.2022 while the complainant was alone in her house and watching Television, at around 8.00 P.M all the accused persons mentioned above forcefully entered in to the house of the complainant and started to shout with filthy and abusive languages in the name of the only son of the complainant named Zeeshan Ahmed, they also asked him to come out of his a room if he hide anywhere in the house of the complainant and threaten to kill him.

3...That the complainant was in very much fear to see MD. Ashraf (Accused No.6) and Nurjahan (Accused No.5) along with two other miscreants holding sharp Cutting Knife in their hands and when she told the accused persons that his son Zeeshan Ahmed is not present in the house at that time. On hearing the same the accused No.1 Rehana Parveen accused No.2 Meherunnisa Khatun along with accused No.3 Feroza Khatun and accused No.5. Salma Parveen started to physically assaulted the complainant by catching hold her hair and at that point of time accused No.3 Feroza Khatun snatched away the golden chain worth Rs. 1,00,000/- (Rupees one lacks only) from the neck of the complainant.

3...That the other accused person started to search every corner of the house of the complainant to find out her only son Zeeshan Ahmed with an intention to kill him, finally when they did not find out her son after searching entire house the accused persons with a common intention forcefully took the key of Almirah from the complainant and steal away Rs. 50,000/- (Rupees fifty thousands) from there and threaten the complainant with dire consequences, by saying that they will kill her son Zeeshan Ahmed whenever they found him.

4...That the Complainant is a widow lady suffering from various physical ailments and living with her only son Zeeshan Ahmed in her house. The complainant since the incident occurred on 18.07.2022 passing each and every moment with out of fear and mental agony.

5...That the complainant informed the matter to the duty officer on table at Purulia (Town) P.S. on the same day but the said officer did not pay any heed to the complaint against the accused persons.

6... That being aggrieved your complainant sent a typed Complaint through registered post to the I.C. Purulia (Town) P.S. on 26/07/2022 but till today no action has been taken against the accused persons and they are roaming freely and also threatening the complainant and his family members. So the complainant and his family members are passing each of every-day out of fears and mental agony.

7...That on 26.07.2022 the Complaint inform the matter to the S.P. Purulla in writing but till date no action has been taken against the accused persons and having no other alternatives your Complainant filed this Misc. Petition u/s 156(3) of Cr.P.C. before this Ld. Court.
