I would like to inform you that one fraudulent person called  
me from his phone no - 7074917296 on 15.08.22 and tell me to pay  
Rs. 10/- to update my electric bill payment and wanted to know  
ATM card no. - 807 etc. which I had shared.

Subsequently he withdrew Rs. 74999/- (Seventy four thousand  
nine hundred ninety nine only) by two times Rs. 25000/- and  
49999/-. I strongly believe that the user of mobile no.  
7074917296 and some others conjointly cheated me.

I shall be obliged if you kindly take an urgent  
necessary action for recovery of my lost money of Rs. 74999/-.
