- 3..That after marriage I had been go to our my matrimonial house at Village Chakirban, P.S. Purulia (M), District Purulia and residing there as husband and wife peacefully .and in my stay at my ~~rest~~ residential house in between our wedlock a male child was born ~~namely~~ Mritunjay Gorai and after born said child Mritunjay Gorain some months expire my said husband and other in laws demanded further dowry amounting of Rs. 50,000/-

but I am unable to full fill their demand by my poor father then they have started physically and mentally tortured upon me and my minor ~~daughter~~ son and the age of our marriage is five years and from beginning I have done all the household duties from morning to late night and prepared and cook the lunch and dinner and supplied the breakfast, dinner and lunch to all the family members and to do all the household work from very morning and night but my matrimonial family members are not satisfied and not to supply me fooding, clothing, medicines etc. including my minor son and not allow share same bed at night and I am spend my night out side of room of my said husband with my minor son. and inspite of that I am staying my matrimonial house that good sense will prevail of my husband and other family members of my matrimonial house but all the hopes are in vain.

4...That at the time of staying my matrimonial house when I demanded to supply me fooding, clothing, medicines etc. but my said did not supply me those essential articles to me and my minor son and not to give proper respect as house-wife and to my minor son and did not care of my minor son due to his illness and always threaten your petitioner to go to her father house.

5...That on 17.04.2022 at night when I am sleeping with my minor son at that time conspiracy my mother-in law Bijala Gorain

It not out of place to mention here that at that time they have snatched my medical treatment papers , Aadhaar card, Birth certificate of minor son and also polio card from your petitioner and good assaulted drive out from the matrimonial house from of your petitioner along with minor son.
