The humble petition on behalf of your complainant  
Most respectfully begs to sheweth as follows:

1. That the complainant is a peace loving and law abiding citizen of the country and on the other hand the accused persons are very desperate and dangerous type of people having no regards to the law of the country.
2. That the accused persons and the complainant are known to each other and inhabitants of Burnpur locality within the jurisdiction of Asansol court.
3. That the on 04.06.2022 when complainant was coming out of Raghunathpur Court after attending his date in Connection with C. Case No.: 51/2016 at A.C.J.M. 2<sup>nd</sup> Court at Raghunathpur and the accused persons no. 2 & 3 also attended the court in connection with the same case, and suddenly the accused persons accompanied with some other unknown persons blocked the road of the complainant and after some hot altercation suddenly the accused no.1 started to assault your complainant with fist and blows and accused no. 2 & 3 abused the complainant in filthy languages and when the complainant objected their such illegal activates the accused no. 1,2 & 3, became more furious and started to assault the complainant and in the mean time the accused no. 2 & 3 snatched Rs.2,000/- forcefully from his pocket and Gold Chain from his neck, seeing the furious attitude of the accused

persons the complainant cried for help and hearing his hue and cry the witnesses along with other local peoples came rushing and

seeing them the accused persons fled away from the spot and at the time of leaving the accused persons threatened the complainant with dire consequences even to kill him.

4. That the matter was informed to the Raghunathpur P.S. on the same day but the local police did nothing except advising your complainant to take shelter of Court and accordingly the complainant was compelled to file this complaint before the Ld. Court for seeking justice for the protection of life and property.
5. That the delay in registering the case is due to the expectation from the Police .
6. That details will be submitted at the time of the trial.
7. That the accused persons have committed offence **U/S 323/506/379/34 of IPC.**

It is therefore prays that your Honour may graciously be pleased to send this petition of Complaint to the Raghunathpur P.S. with a direction to treat the same as F.I.R. U/s 156 (3) of Cr. P.C. and to file its report to the Ld. Court for the ends of Justice.
