Sir,

In producing herewith one arrested accused person namely Rabilochan Sen S/o Lt. Ajit Sen of Nanduara, Ward No 10, PS - Raghunathpur, Dist. - Purulia under arrest along with seized articles as perseizer list i.e. 20 (Twenty) bottles Country Sprit styled as 'Dilkhush' measuring 600 ml in each bottles under proper seizure with label.

1 Sl Subhash Malik of Raghunathpur PS hereby lodged a written complaint against the above noted accused person to the effect that on 03.08.2022 during my mobile duty I received a credible source information that the above noted accused person was selling country sprit illegally in the hotel of the above noted accused at Ward No 8 (on Purulia - Barakar Road) under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with force left to work out the information (This refers to Raghunathpur PS CC No. 2373/22 dated 03/08/2022). At 19:05 hrs we reached at Ward No 8 on Purulia - Barakar Road and my source shown the person from a distance who was selling the liquors. We immediately reached there and surrounded him, but otherpeople who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot and found the huge quantity of country sprit "Dilkhush" bottles were kept there in concealing condition at the hotel of accused person. On searched 20 (Twenty) bottles Country Sprit styled as 'Dilkhush' measuring 600 ml were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers/pedestrian illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused person and labeled, duly singed by the accused person & witnesses in between 19:25 hrs to 19:35 hrs in which 01 (One) bottle of "Dilkhush" measuring 600 ml was kept as sample file with label. During interrogation he confessed his guilt as such I arrested him at 19:45 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Rabilochan Sen S/o Lt. Ajit Sen of Nanduara, Ward No 10, PS - Raghunathpur, Dist.- Purulia u/s-46A (c) of the Bengal Excise Act 1909.
