In producing herewith the arrested accused persons namely (1) Hemanta Gorai (25) S/o Nitai Gorai of Vill.- Bamarrah, PS - Raghunathpur, Dist.- Purulia, (2) Jayanta Gorai (32) S/o Basudeb Gorai of Do, (3) Radhu Gorai (41) S/o Ambuj Gorai of Vill.- Barrah, PS -Raghunathpur, Dist.- Purulia and (4) Ujjal Gorai S/o Shanta Gorai of Do and seized (i) Four wheeler Ash Colour vehicle TATA INTRA bearing Reg. No. WB 81 2903 loaded with Coal measuring approx 02 (two) MT, (ii) One black colour Hero Honda Splendor+ bearing Reg. No. JH 10S/1995 loaded with approx 04 (Four) Qntls. Coal containing in Plastic bags, (iii) One black & red colour Hero HF Delux bearing Reg. No. WB 82A/2303 loaded with coal approx 04 (Four) Ontls. containing in plastic bags, (iv) One black colour Hero Honda Splendor Pro bearing Reg! No. JH 09R/6165 loaded with coal approx 02 (two) Qntls. containing in plastic bags and (v) 20 Pcs. empty plastic bags. Fact of the case in brief is that on 10.08.2022 myself along with S1 Muktipada Ghosh, C/1267 Nabin Patra, C/600 Amit Shit and C/2389 Pinku Saha all of Raghunathpur PS were performing special mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 2431/22. At about 05:15 hrs. received a credible source information that some two wheelers loaded with coal were assembled for loading coal in a four wheeler vehicle with a view to illegal transporting near at Sankra Kali Mandir under Raghunathpur PS. After receiving such information I informed the matter to IC Raghunathpur PS and as per his kind direction we reached near at Sankra Kali Mandir and parked the vehicle from a distance. Then we have cordoned the place by our police personnel and found that some persons having loaded coal in motorcycle were assembled there and one four wheeler vehicle standing there. At that time we were able to apprehend 03 (three) Nos. of motorcycles, one four wheeler vehicle with loaded coal and 04 (four) aforesaid persons. Seeing Police personnel the driver of the said involved four wheeler vehicle and others 05/06 unknown persons were fled away from there. On asking the riders of the said motorcycle failed to produce any papers in respect of said loaded Coal as well as papers in respect of those motorcycles. They also made incoherent statements in respect of possession of the said coal. So, it is reasonable to believe that the rider of those motorcycles: driver of the vehicle bearing Reg. No. WB 81 2903 and others 05/06 unknown persons have been collected the said coal either by theft or by any fraudulent means from anywhere and transporting like !

they confessed their guilt. As such it is every reason to believe that those persons along with motorcycles and one four wheeler vehicle are transporting the said coal illegally. As such I arrested of those persons after observing all formalities and narrating their ground of arrest. I also seized those motorcycles and one four wheeler vehicle loaded with Coal under proper seizure list duly signed by the accused persons and witnesses. No public witnesses were turned up there. Approx 01 (One) K.G. of Coal in each motorcycle and one four wheeler vehicle collected as sample coal.

I therefore pray before you, kindly lodge an FIR against the arrested accused persons namely (1) Hemanta Gorai (25) S/o Nitai Gorai of Vill.- Bamarrah, PS – Raghunathpur, Dist.-Purulia, (2) Jayanta Gorai (32) S/o Basudeb Gorai of Do, (3) Radhu Gorai (41) S/o Ambuj Gorai of Vill.- Barrah, PS – Raghunathpur, Dist.- Purulia, (4) Ujjal Gorai S/o Shanta Gorai of Do, (5) The driver of the offending vehicle bearing Reg. No. WB 81/2903 (Tata Intra) & 05/06 other unknown persons as per law and arrange for its investigation.
