Sir,

In producing herewith the arrested accused person namely Rohan Singh @ Chotu (19) S/o Suraj Singh of Upper Beniasol, PS – Adra, Dist.- Purulia along with seized one Bajaj Pulsar motorcycle bearing No. WB 82E/6545.

I beg to report that today (30.08.2022) myself SI Subhash Malik along with C/480 Uttam Bauri and NVF/1086 Sanatan Mahato were performing special Naka Checking duty at Adra More, Raghunathpur near at Raghunathpur New Bus Stand vide Raghunathpur PS CC No. 2649/22 dated- 30.08.2022. At about 20:15 hrs. I found one IVS Rider motorcycle was coming with heavy speed from Raghunathpur Traffic more side towards Purulia side rashly and negligently. We were tried to stop the said motorcycle rider but he was trying to escape from the Naka point so rashly, there was every possibility of loss / serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.


So, I seized the motorcycle with a view to prosecute him U/S 279 IPC and 184 M.V. Act 1988 in presence of police party and available witnesses duly signed by them. The whole process of seizure was completed in between 20:30 hrs to 20:40 hrs. I also arrested him as he violated Sec. 279 IPC and 184 M.V. Act 1988 at 20:45 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 M.V. Act 1988 may kindly be initiated against accused Rohan Singh @ Chotu (19) S/o Suraj Singh of Upper Beniasol, PS – Adra, Dist.- Purulia and arrange it's investigation.
