Sub: Prayer for lodging F.I.R. against arrested accused person Kripa Sankar Gope (28Y), S/O Gokul Ch. Gope of Vill. - Mantard, PS - Siyaljuri, Dist. - Bokaro (Jharkhand).

Sir,

In producing herewith arrested accused person namely Kripa Sankar Gope (28Y), S/O Gokul Ch. Gope of Vill. - Mantard, PS - Siyaljuri, Dist. - Bokaro (Jharkhand) along with seized one Maruti Suzuki Swift Dzire vehicle bearing reg. No. JH09Z-5949. I beg to report that today I, SI Subrata Sadhu along with 1) C/277 Prabir Mondal, 2) C/1332 Dilip Kr. Baskey all of Santaldih PS were performing Naka checking duty at Harai River Bridge under Santaldih PS vide Santaldih PS C.C No- 3302/22 dtd 12.08.2022 and GDE No- 477 dtd. 12.08.2022. At about 11.45 hrs, I found at Harai River Bridge that one Maruti Suzuki Swift Dzire vehicle bearing reg. No. JH09Z-5949 coming from Chandankiyari side rashly and negligently. We tried to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC. I also seized the vehicle with proper seizure list in presence of witnesses. The whole process of seizure was completed in between 12.15 hrs to 12.25 hrs. His near relative was also informed about the ground of arrest.

Hence, I pray that a specific case U/S 279 IPC may kindly be initiated against Kripa Sankar Gope (28Y), S/O Gokul Ch. Gope of Vill. - Mantard, PS - Siyaljuri, Dist. - Bokaro (Jharkhand).
