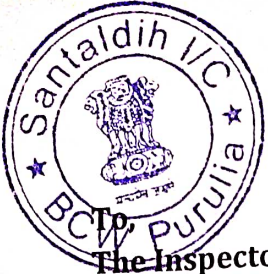

Sir,

I, SI Shuvankar Sarkar, In-charge, Santaldih Investigation centre, PS – Santaldih, producing herewith 5.24 M.T. (approx) seized dust coal under proper seizure list and lodge complaint as suomoto against (i) Sakimuddin Ansary, S/o – Kayem Ansary of Vill. – Parbahal, (ii) Trilochan Mahato, S/o – Lt. Haradhan Mahato, of Vill. – Ushir both of PS – Santaldih, Dist. – Purulia and 03 others to the effect that today (12.08.2022) at 14:45 hrs during my mobile duty, I received a secret information that some persons led by Sakimuddin Ansary of Parbahal village staging huge quantity of stolen coal inside a bush near Gowai river ghat. I inform the matter to I.C Santaldih PS over Cell Phone and as per order of I.C Sanaldih PS, myself along with C/105 Partha Tewary, C/2690 Rakesh Bhakat and NVF/593 Thakurdas Soren left for Gowai river ghat to work out the information. Myself along with force reached at Gowai river ghat at 15:25 hrs and identified the place after searching and found that some persons are staging huge quantity of coal inside a bush near Gowai river ghat. Keeping the vehicle in a safe distance, we conducted raid to apprehend them but they managed to escape from the spot. But we could able to identify two of them namely (i) Sakimuddin Ansary, S/o – Kayem Ansary of Vill. – Parbahal, (ii) Trilochan Mahato, S/o – Lt. Haradhan Mahato, of Vill. – Ushir both of PS – Santaldih, Dist. – Purulia. After waiting for a long hour, nobody turned up to me with all valid papers in respect of the said coal. As such, I seized 5.24 M.T. (approx) dust coal after preparing proper seizure list duly signed by the witnesses and labeled it. Then I arranged to send the seized coal to Santaldih I.C. (BCW) premises for safe custody. Myself held a local enquiry and it came to learn that the above noted persons and 03 others are running clandestine business of coal by fraudulent means and engaged themselves in the business of stolen coal with a view to dispose of the same for their wrongful gain. They purchase the coal in cheap rate from Jharkhand side from by-cycle pullers habitually. I have also collected 1 KG dust coal from the said seized coal as sample

Therefore, I pray to you that a specific case U/S 379/411/413/414 IPC may kindly be initiated against the above noted accused persons.
