Sir,

In producing here with seized approx four (04) M.T coal. I, SI Santosh Kr. Roy would like to inform you that today at about 12:15 hrs. in course of mobile duty I received credible source information that 1) Sk Idu, S/O Lt. Sk Sishu, 2) Sk Safiullah, S/O Sk Safik, 3) Sk Samim Hossain, S/O Sk Rakibul and 4) Sk Abdul, S/O Lt Sk Samsul Haque all are of Vill. Murulia, PS- Santuri Dist-Purulia are digging coal from illegal mines at near Mokra Village, PS Santuri, Dist- Purulia. After receiving this information I informed to O/C santuri PS. As per direction of O/C Santuri PS myself along with force were proceeding towards illegal mines under Mokra village to work out the said information. When we reached near illegal mines under Mokra village, found that some persons were digging coal. Seeing the Police party they fled away from there leaving with their digging coal. We tried to chase them but in vain. Accordingly I seized approx four (04) M.T coal out of this 01 (One) kg coal seized as Sample under proper seizure list in presence of available witnesses duly signed by them but during seizure no public witness could be made available. Thereafter arranging Tractor I brought the above noted seized articles to Santuri P.S. During local enquiry it was learnt that 1) Sk Idu, S/O Lt. Sk Sishu, 2) Sk Safiullah, S/O Sk Safik, 3) Sk Samim Hossain, S/O Sk Rakibul and 4) Sk Abdul, S/O Lt Sk Samsul Haque all are of Vill. Murulia, PS- Santuri Dist-Purulia are running this illegal mining at that area by fraudulent means in clandestine manner.

Therefore, I pray before you that a specific case against the above noted persons may kindly be started as per proper section of law.
