Sir,

In producing herewith the accused persons (1) Dharmendra Sing (25yrs), S/O Ram Sing of Mohuadanga, Asansol Railpar, (2) Ram Bhua (30yrs), S/O Lt. Mangal Bhua of Beldanga, Asansol Railpar, (3) Md Alamgir Mahallah, (4) Md Raj @ Peti (20yrs), S/O Md Afroz of Gujar Asansol (North) PS, Dist.- Paschim Bardhaman and the seized items including one saw, two rod rod, one bamboo stick, one Bhojali.

I SI Santosh Roy of Santuri PS, Dist-Purulia beg to state that during my mobile duty (Santuri PS GDE No- 610, Dtd-17/08/2022) at Madhukunda side I have received a source information at about 22:05 hrs to the effect that few veteran accused persons have been seen assembled behind the Kali Temple near Muradibh Railway Station under Santuri PS suspicious manner with some ill motives. I informed the matter to O/C Santuri PS and as per his kind order I, along with force went there to work out the information.

I reached near the site at about 22:20 hrs and kept the Govt. vehicle No-WB 56C/8993 approx. 100 mtr away from the site and I along with force walked to the site and more or less cordoned from the back side. I along with force heard the whispering of that gang of persons who were planned to commit a dacoity at Krishnapur Bazar area. So I along with force held raid but getting the smell of police, the accused persons ran away and after hot chase we could apprehend five (05) accused persons namely (1) Dharmendra Sing (25yrs), S/O Ram Sing of Mohuadanga, Asansol Railpar, (2) Ram Bhua (30yrs), S/O Lt. Mangal Bhua of Beldanga, Asansol Railpar, (3) Md Alamgir (19yrs), S/O Md Jahangir of Babutalab, Asansol Railpar, (4) Md Raj @ Peti (20yrs), S/O Md Afroz of Gujar Mahallah, (5) Md Saddam Hossain (19yrs), S/O Lt. Md Nasim of Ekbal ground, Asansol Railpar all are under Asansol (North) PS, Dist.- Paschim Bardhaman. 5/6 accd persons managed to flee away in darkness .

I conducted a search of the place and found the following articles: -(I) one saw, (II)two rod, (III) one bamboo stick, (IV) one Bhojali from the place beside them.

I have seized and labeled those articles under proper seizure list after preparing proper seizure list.

I interrogated the accused persons and revealed that they planned to commit dacoity at Krishnapur Bazar area. I arrested them and informed them the ground of arrest.

As such I submit complain against all the five (05) accused persons , i.e, arrested accused (1) Dharmendra Sing (25yrs), S/O Ram Sing of Mohuadanga, Asansol Railpar, (2) Ram Bhua (30yrs), S/O Lt. Mangal Bhua of Beldanga, Asansol Railpar, (3) Md Alamgir (19yrs), S/O Md Jahangir of Babutalab, Asansol Railpar, (4) Md Raj @ Peti (20yrs), S/O Md Afroz of Gujar Mahallah, (5) Md Saddam Hossain (19yrs), S/O Lt. Md Nasim of Ekbal ground, Asansol Railpar all are under Asansol (North) PS, Dist.- Paschim Bardhaman and 5/6 others with a request to start a case in accordance with law .
