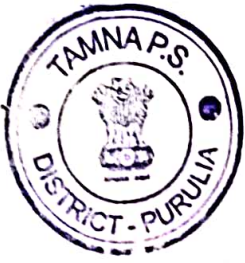

Respected Sir,

I, Nikhil Pratap Singh S/o- Shri Shivkumar Singh of Vill- Majhwalia, P.O- Majlishpur, PS- Kopa, Dist- Chapra (Saran), Bihar SI of Police of Tamna PS in producing herewith, the arrested accused person namely Chandra Deb Gope (29 Yrs.), S/o- Nitai Gope of Vill- Telidih, PS- Tamna, Dist- Purulia (Driver) along with seized article i.e. one Red colour Mahindra 275 DI SP PLUS Tractor having Reg. No- WB55B/5825, Engine No- NNK7EBE0177 & Chassis No- MBNTFAEDBNNK00427 attached with Trolley loaded with sand approx. 100 cft.

The fact of the case in brief is that on 03.08.2022 at about 08:15 hrs received credible source information that one Red Colour Tractor is carrying sand illegally and coming from Beldih side under Arsha PS and going towards Purulia side under Tamna PS, Dist- Purulia. Accordingly, myself along with force i) C/1454 Ashok Kr. Mahato and ii) C/1139 Jiban Senapati left to work out the said source information. Then, we intercepted the aforesaid tractor at near Baligara village under Tamna PS, Dist- Purulia at about 08:35 hrs and found that the above noted tractor was attached with trolley loaded with sand approx 100 cft. But seeing the Police party, driver of the tractor fled away leaving the said tractor attached with trolley loaded with sand at near Baligara village. On hot chased I apprehended the driver of the Tractor with the help of my force at Baligara village under Tamna PS, Dist- Purulia. I asked the Driver of the said Tractor to produce the valid documents regarding carrying the sand which is loaded on the above noted trolley of the said Tractor. But he failed to produce any valid document in respect of the loaded sand into the trolley of said Tractor. So, I arrested the driver of the Tractor namely Chandra Deb Gope (29 Yrs.), S/o- Nitai Gope of Vill- Telidih, PS- Tamna, Dist- Purulia after observing all legal formalities regarding arrest and also issued one copy memo of arrest to him and told ground of arrest and also informed his relatives regarding the ground of arrest. Later on, I seized the above noted Tractor having Reg. No- WB55B/5825, Engine No- NNK7EBE0177 & Chassis No- MBNTFAEDBNNK00427 attached with trolley loaded with sand approx. 100 cft. in presence of witnesses after preparing seizure list. So, there is every ground to reason to belief that the owner and driver of above noted tractor dealing in sand business in clandestine manner.

Under the above facts and circumstances kindly take lawful action against the owner and arrested driver of the seized tractor having Registration No- WB55B/5825, Engine No- NNK7EBE0177 & Chassis No- MBNTFAEDBNNK00427 attached with Trolley loaded with sand approx. 100 cft.
