1, Jagannath Rakshit S/o- Subodh Ch. Rakshit of Vill- Paisabad, PS- Chhatna, Dist-Bankura, ASI of Police of Tamna PS along with force return to PS and brought seized one Blue colour 3032 NEW HOLLAND Tractor without number plate, bearing Engine No- S324E82283 & Chassis No- NIIN30320ZJM452811 loaded with sand approx. 100 cft. and lodged this complaint to the effect that on 03.08.2022, myself along with force i) HG/1861 Dipak Kumar and ii) HG/1858 Dinanath Sing Mura were performing PS area mobile duty. During my mobile duty at about 09:25 hrs received credible source information that one Blue colour Tractor is carrying sand illegally from Chakaltore village side. Accordingly, myself along with force left to work out the said source information. Then, we intercepted the aforesaid tractor near at Chakaltore village under Tamna PS, Dist- Purulia at about 10:05 hrs and found that the above noted tractor was tagged with a trolley loaded with sand (approx 100 cft.). But seeing the Police party, driver of the tractor fled away leaving the said tractor near at Chakaltore village under Tamna PS. We tried to apprehend them but failed. So, there is every reason to belief that the owner and driver of above noted tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper challan or any valid documents related to the said loaded sand of above detained tractor. So, I seized the said Blue colour 3032 NEW HOLLAND Tractor without number plate, bearing Engine No- S324E82283 & Chassis No- NHN30320ZJM452811 along with sand (Approx 100 cft.) loaded trolley. Bring the Tractor at PS after arranging driver from our force.

On return to Tamna PS, kept the aforesaid seized tractor attached with sand loaded (Approx 100 cft.) trolley at PS compound and I do hereby submit written complaint before you to start a cog case against the owner and driver of the tractor without number plate, bearing Engine No-S324E82283 & Chassis No-NHN30320ZJM452811 under proper section of law.
